MAYOR's Budget Instructions (CONT.)

The Mayor's primary instructions to departments include:

- 1. Eliminate discretionary programs.**
- 2. Restructure departments around current staffing levels.**
- 3. Review all contracted services and non-personnel expenditures to identify savings.**
- 4. Reduce all city-wide workorders.**
- 5. Identify redundancy and shared administrative needs.**
- 6. Identify investment opportunities to reduce long-term costs.**

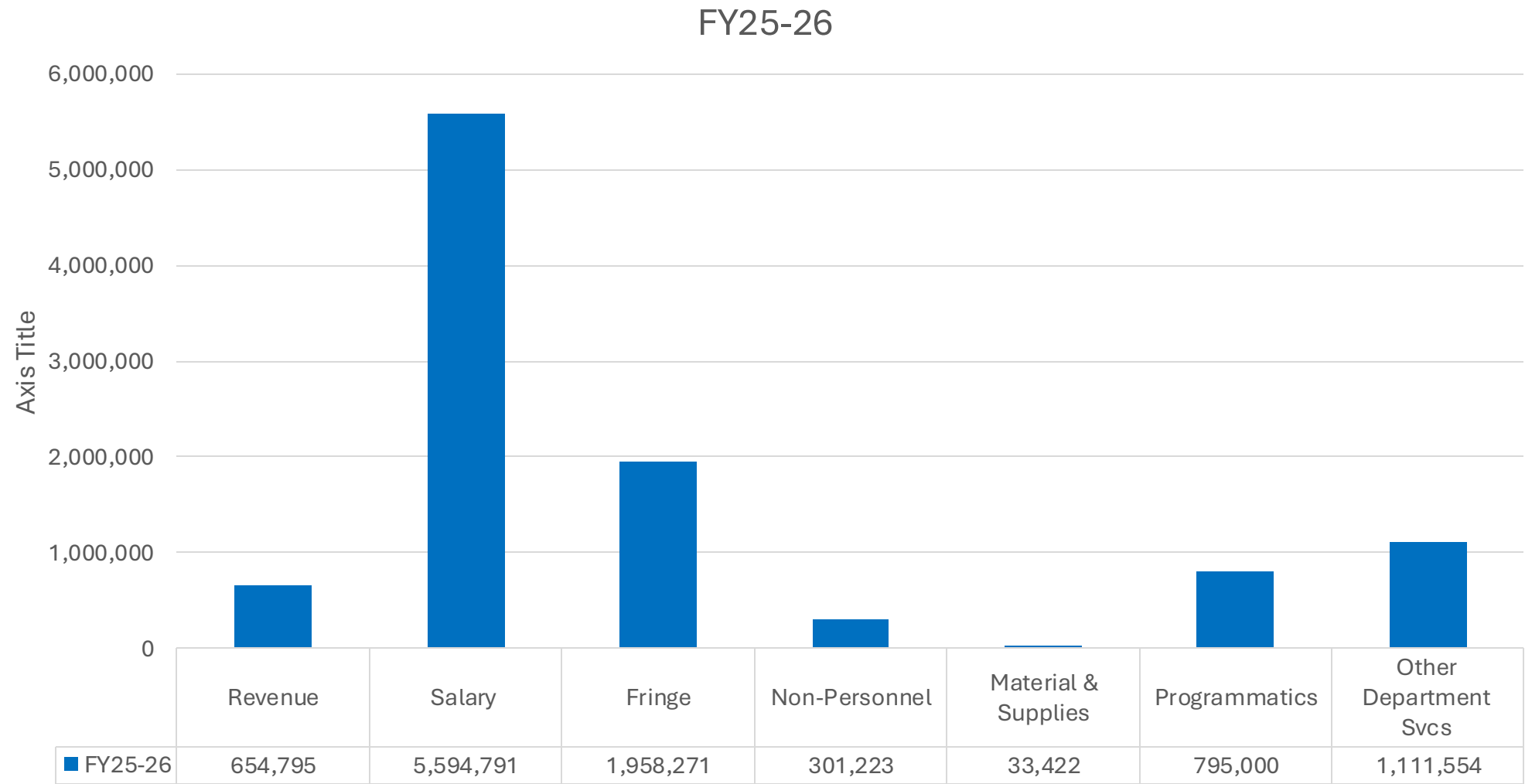

Funding by category

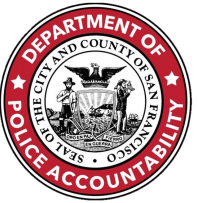

Funding by Expense Category

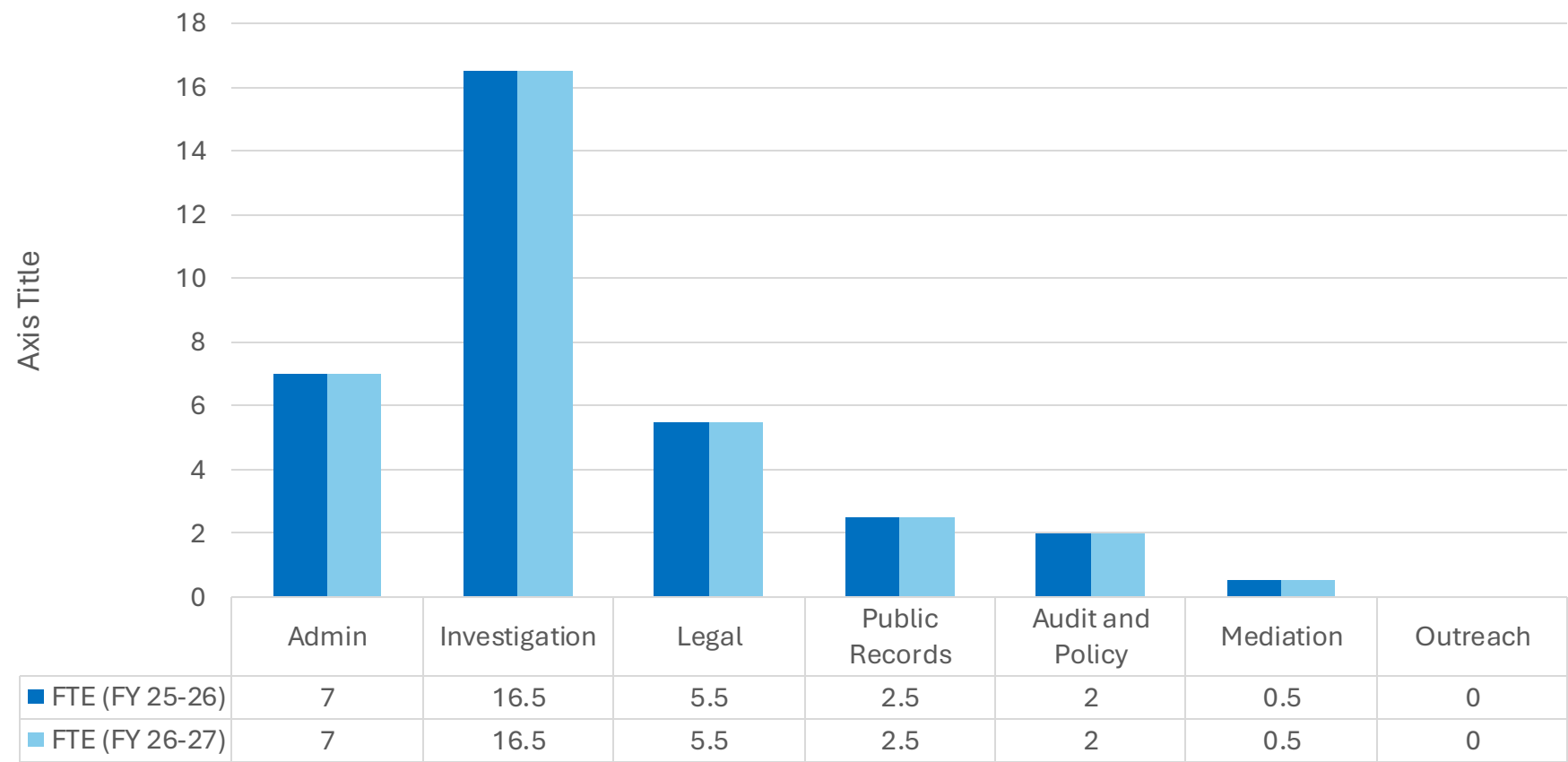

TOTAL	\$9,794,261	100%

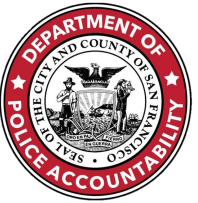

DPA’s Positions BY DIVISION

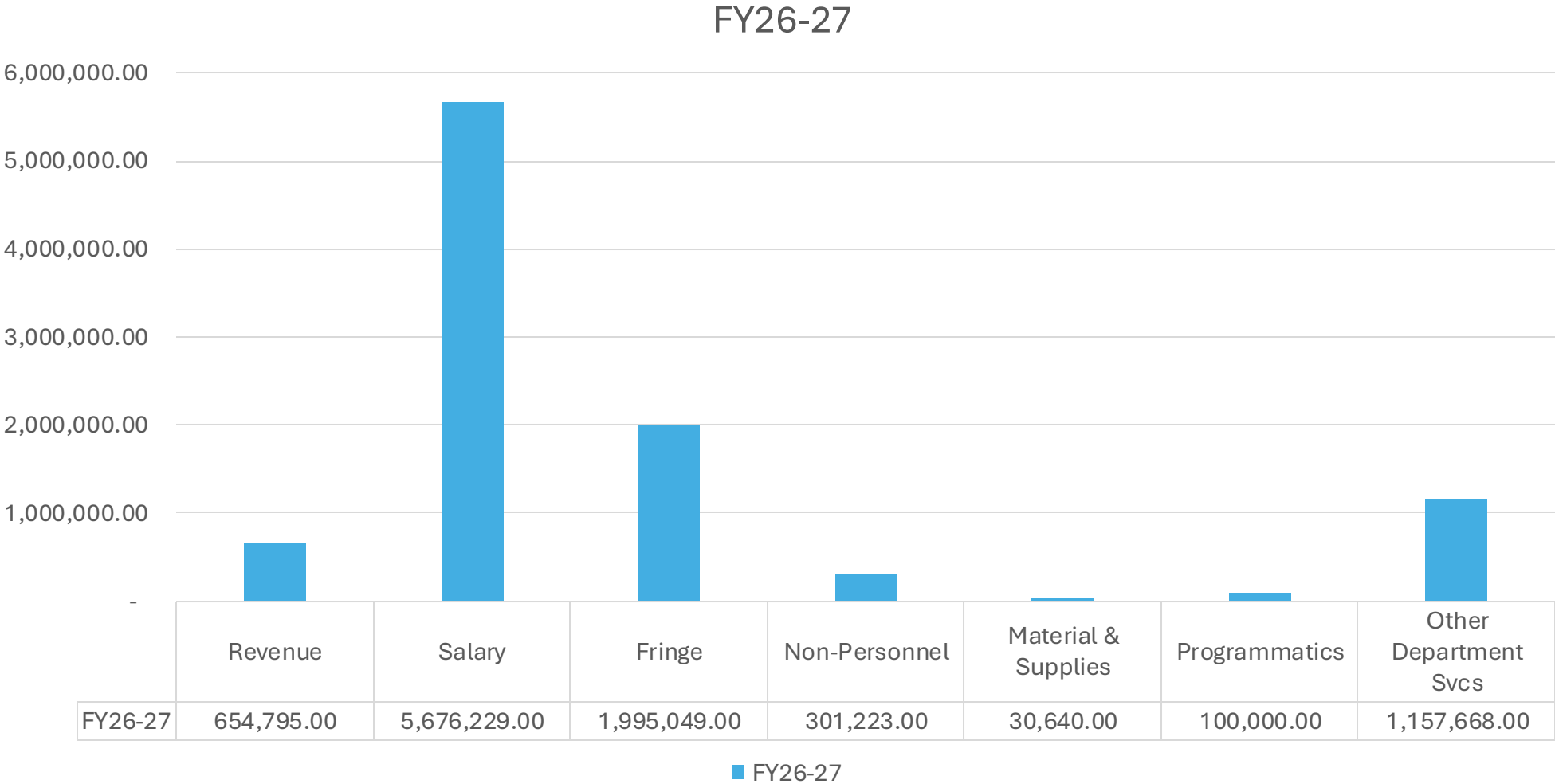
Comparison for FY25-26 & FY26-27

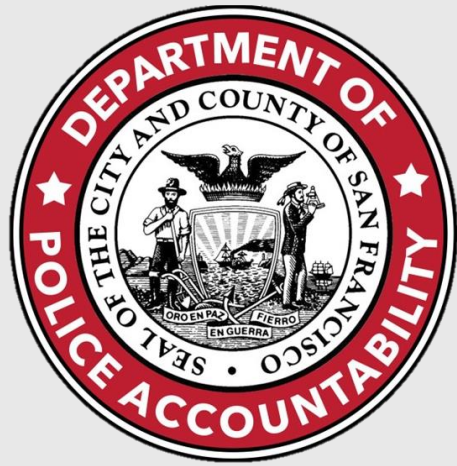
