The Department of Police Accountability's highlight for the week:

■ Budget and Hiring

- The Mayor's Office approved our hiring of a new Policy Director. DPA has made an offer to a candidate who accepted with a start date of March 9, 2026.
- Through DPA's strong partnership with the Mayor's Office, we have also successfully filled four key positions this year. We are excited to welcome a new team member through the Pathway to Hire program next week.

■ Sparks Report

- DPA issued its 2025 Third Quarter Sparks Report.
- DPA's Report Reenvisioning Working Group plans to revise the format of the Sparks Report this year in collaboration with our incoming Policy Director. This effort aims to make the report more accessible, informative, and impactful for the community.

Investigation Updates:

◆ Statistics Since the Last Police Commission Meeting (February 4, 2026):

- **Cases Opened:** 17
- **Cases Closed:** 26
- Year-to-Date Comparison:
 - DPA cases pending adjudication before the Commission and SFPD have trended downward.
 - Volume of incoming complaints this year is lower than for the same period last year.
