Rationale for DGO 6.09 Domestic Violence Working Group

- Engage stakeholders including domestic violence survivors, victim advocates, & SFPD members to:
 - Ensure alignment with Prop. E by making the policy more operationally efficient to enhance SFPD's ability to protect the victims of domestic violence.
 - Inform the update of Domestic Violence Manual ensuring it to be concise and user-focused.
 - Ensure policy allows for victim education regarding the investigative process, victim rights and resources.
- Identify and address common themes of citizen complaints received by
 DPA on policy implementation and address emerging training needs.

Rationale for DGO 5.23 Interactions with Deaf and Hard of Hearing Individuals Working Group

- Direct impact on community.
- Review technology options as a resource to both officers and Deaf and Hard of Hearing individuals.
- Engage stakeholders including DPA and community members to address policy implementation gaps and/or identify new training needs.
