## Summary for February 4, 2026

The Department of Police Accountability's highlight for the week:

### ▪ DPA Digitization Project

- DPA successfully completed scanning all historical files from 1985 to 2019, preserving decades of records.
- Currently verifying accurate file tagging to ensure reliable digital searches and retrieval.
- Preparing to migrate all files from local servers to secure cloud storage, enhancing accessibility and security.
- Project remains on schedule for completion by the end of this fiscal year in June.

### ▪ Digital Accessibility and Inclusion Standard (DAIS) Project

- DPA is on track to meet City, State, and Federal compliance standards for digital content.
- Expected to achieve full compliance on or before the federal deadline of April 24, 2026.

### ▪ Audit

- DPA completed its 2025 audit in December: "*SFPD: Opportunities Exist to Strengthen Use-of-Force Oversight.*"
- Will present findings and recommendations to the Police Commission at this meeting.

### ▪ Hiring

- DPA hired a new investigator, and the investigator started on February 2, 2026. This fills a vacancy created last year.

## Investigation Updates:

### ♦ Statistics Since the Last Police Commission Meeting (January 21, 2026):

- **Cases Opened:** 36
- **Cases Closed:** 35
- Year-to-Date Comparison:
  - DPA cases pending adjudication before the Commission and SFPD have trended downward.
  - Volume of incoming complaints were slightly lower January 2026 compared to January 2025.
