Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Lew, before reporting on crime trends, responded to Ms. Brown's inquiry regarding monitors at the stations and stated that facilities are doing an audit at each of the stations to make sure the monitors are in good working order.

Chief Lew then reported on crime trends YTD: Violent Crime down 39 percent; homicide, no homicide this week; rape down 60 percent; robbery down 40 percent; assault down 33 percent; human trafficking N/C. Property Crimes down 36 percent; burglary down 22 percent; motor vehicle theft down 100 percent; arson down 56 percent; larceny theft down 58 percent. Gun violence is down 75 percent compared to 2025; One shooting incident this week; total 2 fire-arm related incidents resulting in 2 victims YTD. No homicides for the week; there are a total of 0 homicides YTD.

Significant Incident: Zero reported homicides. One non-fatal shooting resulting in injury to one victim on 1/11/26. YTD there are two related firearm incidents resulting in two victims. On January 10, 2026, at 6:55 a.m., on Jones in the Tenderloin, report of a victim who was shot with non-life threatening injury, no arrest made and is an open investigation. There were three stabbings that occurred: On January 11th, on Mission and Geneva in the Ingleside, at approximated 8:32 p.m., officers responded and located two victims suffering from stab wounds, no arrest made and is an open investigation. On January 10th, at approximately 9:50 p.m., on Post and Larkin in the Northern, officers responded and located a victim suffering from stab wounds, arrest was made in this incident. On January 10th, at 1656 hours, at 16th and Mission in the Mission, officers responded to the scene of a stabbing due to an altercation. A victim was located with stab wounds, four people were taken into custody and booked, investigation is ongoing.

Significant arrest: On January 5th, at approximately 11:30 a.m., officers responded to the area of Embarcadero and Brannan Street regarding a person threatening to hurt herself. Officers arrived on scene and located a female who was in crisis, believed to have a firearm. The officers on scene, along with the hostage negotiation team and tactical elements, the subject was taken into custody with no incident, and the incident was successfully de-escalated.

Strategies: Chief Lew reported that the Department is preparing for a few things: The department is staffing up for any impromptu or last minute protests due to national issues; A Bob Weir memorial at Civic Center, expected 20,000 people; Forty-Niners playoff game where a lot of people are expected to be out on the streets. Superbowl staffing – more than 50 events hosted in San Francisco related to the Superbowl, days off are cancelled for SFPD officers, increased officer's shift time from 10 hours to 12 hours to provide more officers to keep all areas of the city safe. Officers who are off duty will come in to work on of the Superbowl event, on the overtime basis. In addition, different police bureaus like Investigations and Administration will run skeleton crew with the remainder assigned to Superbowl events. Special Operations Bureau will be deployed to Superbowl operations. Airport Bureau will be managing the large number of VIPs arriving throughout the week and general increase in visitors.
