Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Lew then reported on crime trends YTD: Violent Crime down 16 percent; homicide, 14 YTD; rape down 12 percent; robbery down 29 percent; assault down 8 percent; human trafficking down 13 percent. Property Crimes down 29 percent; burglary down 32 percent; motor vehicle theft down 34 percent; arson down 10 percent; larceny theft down 28 percent. Gun violence is up 6 percent compared to 2025.

Homicide Incidents: Zero homicides reported this week. 14 homicides year-to-date, with 9 resulting from a firearm.

Shooting Incidents: There were two shooting incidents causing injuries to two victims the week ending 4/5/26. On April 4, 2026, at approximately 8:30 p.m., at 6th and Minna in the Southern, officers responded and located a victim with a gunshot wound. Victim was transported to the hospital with non-life-threatening injury. No arrest made and is currently an ongoing investigation. On April 4, 2026, at approximately 11:54 a.m., at Cambon and Cardenas in the Taraval, officers responded and located a victim suffering from a gunshot wound. Victim was transported to the hospital with non-life-threatening injury. No arrest made and is currently an ongoing investigation.

Significant Operations/Arrests: Officers arrested four suspects in a robbery as well as an auto burglary series. On April 1, 2026, citywide plainclothes team conducted a robbery/auto burglary abatement operation. Officers learned a robbery had occurred in the Taraval near the 2200 block of Irving. Officers were advised that the victim was waiting at the bus stop when two suspects approached her. One of the suspects grabbed the victim's purse and fled towards a waiting vehicle. The victim suffered non-life-threatening injury. With the assistance of RTIC (Real Time Investigation Center) officers attempted to locate the vehicle and learned that it was also involved in an additional two auto burglary incidents near the Legion of Honor. Eventually, the vehicle was located near the Palace of Fine Arts by drone operators and the occupants of the suspect vehicle were observed casing multiple vehicles and committing two additional auto burglaries. Officers developed a plan to safely take the suspects into custody near the area of Van Ness and Lombard. Suspects were taken into custody. The robbery victim along with three auto burglary victims were reunited with their recovered stolen property. On April 7, 2026, at approximately 7:14 a.m., officers observed a male committing a traffic violation at Hyde and Eddy. The officers stopped and detained the subject. During this contact, officers discovered that the subject had 8 outstanding warrants for his arrest and that the subject was in possession of a destructive or explosive device. Members of EOD (Explosive Ordinance Disposal) responded and rendered the device safe. Suspects were booked for the multiple warrants as well as for possession of a destructive device.

Major Events: The Cherry Blossom Festival starts on Saturday, April 11th. SFPD will be walking the parade route on April 19th and the Commission are invited.

Commissioner Scott expressed concern regarding Lisa Ortiz and how she's been instrumental in making sure victims and survivors maintained a healthy relationship with SFPD. Commissioner Scott spoke of how important her role is in pulling victims and survivors together and to have them continue to work with SFPD.

PUBLIC COMMENT:

Ms. Paulette Brown showed the flyer for SFPD Victims' Walk on Monday, April 20th, at Civic Center Plaza starting at 4:30 p.m., and she asked for Ms. Ortiz's job back. She spoke of her son's recent birthday and all the unsolved homicides.


