Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Chief Lew then reported on crime trends YTD: Violent Crime down 28 percent; homicide, 9 YTD; rape down 3 percent; robbery down 41 percent; assault down 21 percent; human trafficking down 29 percent. Property Crimes down 36 percent; burglary down 42 percent; motor vehicle theft down 41 percent; arson down 41 percent; larceny theft down 33 percent. Gun violence is down 5 percent compared to 2025. There was 1 non-fatal shooting incident causing injuries to 1 victim for the week ending 3/1/2026.

Shooting Incidents: On March 1, 2026, at approximately 12:40 p.m., in the area of Evans and Selby in the Bayview, officers responded and located a victim suffering from a gunshot wound. Victim was transported with non-life-threatening injuries. No arrest made and is an ongoing investigation. On March 4, 2026, at approximately 0400 hours, in the 700 block of O'Farrell, officers located a victim with a gunshot wound. Victim was transported with life-threatening injuries. No arrest made and is an ongoing investigation.

Homicide Incidents: On February 27, 2026, at approximately 10:04 a.m., at Dakota and 25th Street in the Bayview, two victims were located suffering from gunshot wounds. One of the victim succumbed on scene and the second victim was transported with life-threatening injuries. No arrest made and is an ongoing investigation. On March 4, 2026, at approximately 1:31 a.m., at the 100 block of 6th Street, officers responded and located a victim suffering from gunshot wounds. Victim was transported to SFGH with life-threatening injuries and was later declared deceased at the hospital. This is an ongoing investigation.

Significant Arrests: Officers arrested a suspect in a hate crime vandalism of a San Francisco church. On February 28, 2026, at approximately 8:45 a.m., officers responded to a report of homophobic and antisemitic graffiti at a church located on the 2400 block of California. The officers located a suspect and established probable cause and placed suspect under arrest. The total damage exceeded \$20,000. On February 27, 2026, at approximately 8:55 p.m., officers responded to the area of 4th and Channel Street, on a report of a vehicle striking two pedestrians, an adult and a 2-year-old child. The victims were transported to a local hospital. The child was declared deceased at the hospital. The driver remained on scene and was cooperative.

MAJOR EVENTS: Lunar New Year Parade on March 7th. Red Bull F-1 event was largely a peaceful event, however, there were issues with congestion, people climbing on private property, rooftops, and balconies. There were approximately 50,000 attendees. With regard to the Middle East, Iran Demonstrations, there was a demonstration on February 28th, that originated at the Federal Building with approximately 500 attendees. Event was largely peaceful. On March 2nd, there was another demonstration at Embarcadero Plaza with no issues.

Director Henderson reported the following: 32 cases opened; 45 cases closed. 11 cases open for more than 270 days. There are 67 cases sustained by DPA that are pending with the SFPD and 3 cases pending with the Commission. There are 197 cases under investigation


