Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott addressed his departure from the Department. Thanked the Commission, the Department and the public.

Chief Scott, reported on crime trends YTD: Violent Crime down 16 percent; homicide down 27 percent; rape down 27 percent; robbery down 22 percent; assault down 11 percent; human trafficking up 83 percent. Property Crimes down 29 percent; burglary down 23 percent; motor vehicle theft down 43 percent; arson down 26 percent; larceny theft down 27 percent. Gun violence is 0% change compared to 2024; two non-fatal shooting incidents this week; total 39 fire-arm related incidents resulting in 45 victims YTD. One homicide for the week; there is a total of 8 homicides YTD with 7 resulting from a firearm; 113% overall clearance.

Significant Incident: One homicide, 1900 block of Sunnydale in the Ingleside, two victims shot, one victim succumbed to injuries, second victim transported and in stable condition, no arrests, investigation ongoing. Suspicious death occurred on the unit block of Laguna Street, Park District, 5/6/25 15:19, Officers responded to a call of a deceased person, Medical Examiner determined that the death was suspicious, Homicide investigators went to scene to investigate, waiting on findings from Medical Examiner. Two shootings – 1st shooting, 2nd and Harrison, 5/5/25 06:15, subject approached vehicle shouting at occupants in vehicle, occupants could not make out what was being said, wife of victim brandished a firearm, struggle ensued between wife of victim and subject, victim them struck by bullet, wife transported victim to hospital, victim in stable condition, investigation ongoing. 2nd shooting – 600 block of Hampshire, Mission District, victim shot and is in stable condition, subject unknown, investigation ongoing. Significant arrest: Stabbing on 1100 block of Phelps, Bayview, 5/5/25 01:40, after drinking alcohol, an altercation broke out between victim and subject, subject eventually stabbed victim, subject arrested and victim in stable condition expected to survive injuries. Stabbing, 5/5/25 23:00, unit block of Clarion St, Mission District, victim and subject at victim's residence when they began to fight, subject stabbed victim, victim in stable condition, expected to survive, Officers were able to separate the parties and based on investigation arrested the subject. Homicide arrest, homicide occurred on May 2nd, 26th and Mission, involved a domestic situation that resulted in the death of a male victim, during investigation identified subject responsible for homicide, conducted a warrant in Marin County and took subject into custody, subject charged with homicide. Homicide, 5/14/25-today, 13:00, Officers responded to area of Columbus and NorthPoint regarding a shooting, while en route Officers learned that an unknown male was inside a vehicle and shot into another occupied vehicle and immediately fled the area, Officers conducted preliminary investigation, Officers learned that suspect had turned himself in at Central Station, investigation ongoing, Officers located victim and vehicle matching description, parked in area of Leavenworth and Beach St, Officers approached vehicle and observed unresponsive male in driver's seat suffering from gunshot wounds, Officers rendered aid, Paramedics arrived and rendered aid, despite efforts victim was pronounced at scene, Homicide Unit leading investigation.

Strategies: Side show event, 5/10/25, parking lot near Pier 32, couple hundred cars, Southern Station and Stunt Driving Response Unit responded, dispersed all the cars from Pier 32, CHP assisted with helicopter, video evidence to impound vehicles.

Neglect of Duty-The officer failed to make an arrest-8%.
