Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott, reported on crime trends YTD: Violent Crime down 16 percent; homicide down 25 percent; rape down 30 percent; robbery down 23 percent; assault down 9 percent; human trafficking up 83 percent. Property Crimes down 29 percent; burglary down 23 percent; motor vehicle theft down 43 percent; arson down 24 percent; larceny theft down 27 percent. Gun violence

is 2% change compared to 2024; Zero non-fatal shooting incidents this week; total 40 fire-arm related incidents resulting in 46 victims YTD. One homicide for the week; there is a total of 9 homicides YTD with 8 resulting from a firearm; 122% overall clearance.

Report out on unsolved homicide cases, per Commission request- pulled from agenda.

Significant Incident: Stabbing, 800 block of Polk Street, 5/12/25 23:48, subject and victim in an argument, second victim went to break up argument, second victim stabbed by subject, no arrests made, investigation ongoing. Stabbing at 6th in the Southern District 5/13/25 01:16, victim assaulted by several subjects who have not been identified and stabbed in the process, no arrests made, still under investigation. Significant traffic collision involving an off-duty member, Sunset Blvd. and Rivera, 5/17/25 01:59, Officers responded to collision, two occupied vehicles, victim vehicle occupied by three adults, paramedics transported three victims to hospital, one victim sustained life threatening injuries, two victims sustained non-life threatening injuries, two occupants of second vehicle transported with non-life threatening injuries, during course of investigation Officers determined that suspect driver was driving under the influence of alcohol and was placed under arrest, identified suspect as 28 year old SFPD Officer who just graduated from the academy, suspect booked on multiple charges, member is no longer a part of the police department.

Significant arrest: One homicide, 1200 block of Columbus Ave, Central District, subject shot victim, victim succumbed to injuries, victim found in car not far from where shooting happened, subject turned himself in to Central Station, case charged, shooting solved due to subject turning himself in. Aggravated assault at the 400 block of Bay Street, Central district, 5/15/25 18:25, employees confronted subject for shoplifting inside a Trader Joes, subject dropped item inside store, as employees escorting subject outside store subject took out handgun and pointed it at employees then took off running, Officers responding were able to locate person and gun, made arrest. Stabbing at Caledonia St and Sparrow in the Mission District, 5/18/25 04:36, victim and subject in an argument when victim was stabbed, subject taken into custody by responding Officers. Attempted robbery 5/18/25 17:50, 1100 block of Lombard, Central District, two victims on street when four subjects got out of a car and approached them, one subject pointed a firearm at the victim and demanded property, victims refused, subject assaulted by pistol whipping victims, four subject fled scene, Officers responded and were able to located and arrest all four juvenile subjects.

Strategies: Homicide clearance rate at 122%, meaning previous years' homicides solved.

PUBLIC COMMENT:

Paulette Brown: Spoke about unsolved homicides and provided an article for reference. Continued to elaborate on those involved, provided a list of names. Expressed that she will miss Chief Scott, him being attentive and personable.

Chantel Rose: Spoke about photos of wanted suspects. Addressed question to Chief, Chief responded. Continued to ask specific questions.
