## Highlights for July 15, 2025

The following report includes the Department of Police Accountability's recent developments:

- As part of their final project, DPA's summer interns are reviewing SFPD's policies and practices related to First Amendment activities, outlined in DGO 8.10.
  - The policy was last updated in 2009, and the last working group met in July 2023.
  - The project builds on two prior DPA audits, with the goal of developing recommendations to inform policy updates.

## Investigation Updates

- Statistics Since Last Commission Meeting on July 9, 2025:**
  - Cases Opened/Closed:** Our office opened 16 cases and closed 16 cases.
  - Cases Opened:** Increased 26% (106 cases) compared to 2024 year to date.
  - Cases Past 270 Days:** As of July 15, 2025, all cases past 270 days are tolled.
