Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 18 percent; homicide down 23 percent; rape down 33 percent; robbery down 25 percent; assault down 10 percent; human trafficking up 100 percent. Property Crimes down 29 percent; burglary down 23 percent; motor vehicle theft down 43 percent; arson down 23 percent; larceny theft down 26 percent. Gun violence is 5% change compared to 2024; One non-fatal shooting incident this week; total 46 fire-arm related incidents resulting in 53 victims YTD. No homicides for the week; there is a total of 10 homicides YTD with 8 resulting from a firearm; 130% overall clearance.

Significant Incident: One shooting, two injuries, 6/6/25 23:58, Madrid and Russia, report of drive by shooting, black sedan, leaving at high rate of speed, Officers arrived and located two victims, victims

transported, one victim stated they were about to enter a residence when they heard what sounded like an explosion and realized they were injured, Officers detained a subject on scene that matched description of subject, later determined that there was no match, no arrest made. Officer being hospitalized on 6/8/25 20:00, Central District, in relation to 1st Amendment activities, protestors throwing objects at Officers in a squad, at least one Officer hit, that Officer is in stable condition. Traffic collision fatality, 6/2/25 00:01, Geary and 2nd, Richmond District, pedestrian crossing street pushing wheelchair when struck by vehicle, pedestrian sent to hospital and succumbed to injuries, no arrests at this time, under investigation.

Significant arrest: Aggravated assault, mayhem, 6/6/25, 16:39, Laguna and Marina, Fort Mason entrance, Northern, victim and subject in a physical altercation, during fight victim's ear completely severed off, subject fled scene, subject reached Laguna and Bay St where they assaulted a random female, Officers apprehended subject after foot pursuit, both victims in stable condition, arrest made. Aggravated assault on Peace Officer, 6/3/25 17:34, 300 block of 32nd Ave, Richmond District, subject told multiple times to leave as a trespasser to leave area by Officers, subject refused, subject got into a vehicle, Officer's attempted to stop the subject, continued into vehicle, accelerated vehicle and struck Officer, Officer landed on hood of suspect's vehicle, suspect arrested, Officer transported.

Strategies: No side show events reported this week in San Francisco. First Amendment activities in San Francisco, actively coordinating with city partners to keep San Francisco safe in response to the recent protests related to immigration policy and issues, Chief Yep read statement.

Executive Director Henderson reported the following: In the year 2025: 404 cases opened; 419 closed; 100 pending; 19 cases sustained; 14 cases past 270-day; 3 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting)**: 16. Central, 2. Southern, 3. Bayview, 0. Mission, 2. Northern, 0. Park, 0. Richmond, 0. Ingleside, 2. Taraval, 0. Tenderloin, 2. Airport, 0. Not Applicable, 2. Out of Jurisdiction, 1. Pending, 2. Allegation Summary: Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-41%. Neglect of Duty The officer failed to promptly respond to a scene-10%. Neglect of Duty-The officer failed to properly investigate-10%. Neglect of Duty-The officer failed to take required action-10%. Neglect of Duty The officer failed to write an incident report-7%.

Audits: DPA's audit of SFPD's use of force update: • This audit reviews how SFPD supervisors evaluate use-of-force incidents. • To help ensure comprehensive and informed analysis, DPA is surveying SFPD supervisors to incorporate their insights into the audit. • DPA sent the survey to supervisors on June 2nd, with a reminder email on June 9th. The survey will close on June 16th.

Outstanding Issues: Budget FY 2025-2026 and 2026-2027- The DPA is scheduled to present its budget to the Board of Supervisors' Budget and Appropriations Committee on Friday, June 13, 2025. Investigation Updates- Statistics Since Last Commission Meeting on June 4, 2025: DPA opened 16 cases and closed 32 cases.
