### 1. Purpose (5.14.01) [Modified]

*Terminology updated; phrasing on notification and approval softened*

*Approval authority moved from Deputy Chief to Commander; new MOU exception added*

| All interagency operations require prior approval of the member's Deputy Chief, with no stated exceptions. Deputy Chief approval is also required before SFPD can request assistance from an outside agency. | Only operations not governed by a Memorandum of Understanding (MOU) require prior approval, and that approval now comes from the Commander of the participating unit rather than the Deputy Chief, who is notified only as an escalation, "if necessary." The approval authority has shifted from the Deputy Chief to the Commander because this allows for operations to be conducted more timely and dynamically and Commanders typically have greater knowledge of the interagency operation than a Deputy Chief. |

| Not addressed. | New pathway: for non-exigent but time-sensitive operations, members may request and receive verbal approval from their Commander. The Commander should confirm approval by email when practical, and a Form 630 marked "verbal notification" is completed after the operation. These operations are necessary for time-sensitive circumstances that require administrative efficiency. |

The approval authority has shifted from the Deputy Chief to the Commander because this allows for operations to be conducted more timely and dynamically and Commanders typically have greater knowledge of the interagency operation than a Deputy Chief. |

*Mandatory Deputy Chief-led briefing dropped entirely*

*Entirely new section barring participation that violates local or state law, including SF Sanctuary Laws*
