The Department of Police Accountability's highlights for the week:

- **Audit Update**
 - DPA has issued its audit report on SFPD's processes for monitoring use-of-force incidents and is scheduled to present to the Police Commission on February 4th.
- **Executive**
 - The DPA Reports Working Group has redesigned the quarterly report format to make it clearer, more efficient, aligned with the mayor's new reporting guidelines, and fully compliant with the new Digital Accessibility Inclusion Standards.
- **Training**
 - DPA's attorneys and investigators attended a tabletop exercise to discuss containment tactics for armed suspects, hosted by the Field Tactics and Force Options unit at the Academy.

Investigation Updates:

- ♦ **Statistics Since the Last Police Commission Meeting (Nov 19, 2025):**
 - **Cases Opened:** 87
 - **Cases Closed:** 99
 - Year-to-Date Comparison:
 - **Case openings are coming in slower at the start of this year (3) compared to this time last year (7).**
 - **Case closures are up** compared to this time last year.

Conduct Unbecoming an Officer	The officer behaved or spoke inappropriately	18%
Unwarranted Action	The officer engaged in unwarranted action	8%
Unwarranted Action	The officer conducted an improper search or seizure	6%
Unwarranted Action	The officer detained a person without reasonable suspicion	5%
