DEFINITION

Under general direction:, supervises the overhaul, maintenance, and repair of a wide variety of mobile and stationary machinery, equipment, and mechanical facilities in buildings, structures, and adjacent areas at the San Francisco International Airport (SFO) performs supervisory duties in maintaining, operating and repairing airport mechanical machinery and equipment; and performs related duties.

Requires responsibility for: interpreting, coordinating and enforcing the policy, methods and procedures related to the maintenance and repair of large and varied stationary mechanical machinery and equipment at the San Francisco International Airport; effecting considerable economies by supervising the proper operation, maintenance and servicing of mechanical equipment of high value; preparing and checking and reviewing inventory, repair and ordinary operating records and reports. Nature of work requires the application of a wide range of technical skill and procedures to determine proper action to be taken in maintaining and repairing large and varied mechanical machinery and equipment.

DISTINGUISHING FEATURES

The 9232 Airport Central Plant Superintendent is distinguished from the 7205 Chief Stationary Engineer in that the former is the highest-level supervisor overseeing the Stationary Engineer series at SFO and is responsible for the supervision, through subordinate supervisors, of stationary engineers engaged in a wide variety of skilled technical functions, whereas the latter is the second-level supervisor in the Stationary Engineer series responsible for less complex facilities and grounds, specific functional areas or projects, and the direct supervision of engineering crews.

SUPERVISION EXERCISED

Supervises subordinate staff.

EXAMPLES OF IMPORTANT AND ESSENTIAL DUTIES

According to Civil Service Commission Rule 109, the duties specified below are representative of the range of duties assigned to this job code/class and are not intended to be an inclusive list.

- Supervises the operation and maintenance of stationary mechanical machinery and equipment at the San Francisco International Airport; <u>develops and implements maintenance</u>, <u>repair</u>, <u>and overhaul methods and procedures</u> <u>assigns duties and work to operating engineers and others</u>, and is responsible for completion of work; checks and approves time sheets.
- 2. Arranges s**S**chedules for routine servicing of plant equipment such as lubrication of machinery, washing down sewage pumping station sumps, cleaning filtration air ducts and filters, and tests of emergency equipment.
- 3. Maintains <u>detailed records of mechanical equipment, including</u> a-machinery history, <u>-of the mechanical equipment showing make</u>, model, serial numbers, local dealers' name <u>wad and</u> address, repair data and cost of <u>maintenance and</u> repairs; <u>prepares and reviews operational</u>, <u>maintenance</u>, <u>and repair reports</u>.
