PUBLIC COMMENT INFORMATION

Members of the public may address the Commission for up to three minutes on any matter within the Commission's jurisdiction. The Commission will hear public comment on all agenda items before, or during discussion of, the item. The Commission will also hear public comments on items not listed (see Agenda, Item 4).

The period of time allowed for public comment may be modified by the Chair in the interest of fairness to all those wishing to address the Commission. Speakers shall address their remarks to the Commission as a whole and not to individual Commissioners or Department personnel. The lack of a response by the Commissioners or Department personnel does not necessarily constitute agreement with, or support of, statements made during public comment.

Public comment may be made:

- 1) In person at the meeting.
- 2) By email to JUV-ProbationCommission@sfgov.org if received no later than 12:00 pm the Thursday before the meeting.
- 3) By leaving a voicemail at 415-271-2861. Comments submitted no later than 12:00 pm the Thursday before the meeting will be read into the record during the meeting and will be treated as a substitute for providing public comment during the meeting.

NOTE: Persons who submit an agenda item by written public comment or by voice mail in advance will not be permitted to provide public comment on the same agenda item(s) in person during the meeting.

DISABILITY ACCESS & ACCOMMODATION

LOBBYIST ORDINANCE

Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code 2.100] to register and report lobbying activity.
