Subject: Updated HSH Multiyear Procurement Plan

On December 4, 2024, the Department of Homelessness & Supportive Housing (HSH) released its multiyear procurement plan (MYPP) that outlines the formal competitive bidding processes and timelines that the Department plans to conduct for each service area. The plan represents an exciting opportunity for thoughtful planning of HSH's funded services and alignment with its equity and performance goals.
