Item 1.0 Call to Order by Chair Harriette S. Stevens, Roll Call taken by BHC Clerk.

Item 2.0 Motion to adopt the Rules and Reports Meeting Minutes from January 7, 2026, by Commissioner Jackson-Lane and seconded by Commissioner Mason.

Item 3.0 The discussion addressed Health Right 360 Resolution, advising that the resolution should focus on Program 890 instead of the overall organization. The committee requested the

BHC Clerk to provide information related to site reviews and presentations regarding Health Right 360 and Friendship House. Additionally, the committee agreed to invite Transitional Aged Youth Services and San Francisco behavioral health staff, on behalf of black workers, to present to the full commission.

The committee recommended forwarding the draft resolution to the executive committee and specifying the commission's authority and limitations. The resolution should include the need for urgency, transparency in public report training, training staff on mental health burnout, retention, and safety.

Item 4.0 The discussion noted that the Black workers' request lacked clarity, hindering the determination of the appropriate support that the BHC could provide. It emphasized the importance of adhering to the commission's scope of authority. While the Commission can make recommendations on behavioral health system workforce development, diversity, equity, and inclusion, it cannot address citywide human resources issues or legal complaints.

Sections of the proposed resolution were reviewed to identify which fall within the commission's jurisdiction. The draft resolution will need to undergo further review to ensure that the commission stays within its authority as an advisory board.
