Program Presentations

Target: ~6 presentations annually (one per commission meeting).

At least 3–4 commendations/recommendations typically arise from these presentations.

Upcoming speakers include Transitional Age Youth Services.

Site Visits

Goal: At least 4 site visits per year.

Recent visits: Westside Crisis, Behavioral Health Access, Friendship House, Health Right 360 (890 Hayes), Progress Foundation (Avenues).

Not all visits count toward the current strategic plan period.

Commendations & Recognitions

Typically, 3–4 per year, but none completed yet for this cycle.

Recognitions require either a site visit or a presentation to commissioners.

Potential candidates: Friendship House, Progress Foundation (Avenues), Health Right 360, Homeless Children's Network (pending response), Westside Crisis.

Pending Items

Homeless Children's Network: Awaiting site visit/presentation and response from leadership.

Larkin Street and other youth service providers to be contacted for presentations and possible board recruitment.

Bridge Housing is identified as important for future presentations due to its role in connecting housing and mental health services.

Action Plan:

Compile a summary for each program (2–3 sentences) describing site visits/presentations and program impact.

Bring organized list of proposed commendations and recognitions to the executive committee in November for approval, then to the full commission.

Recruitment:

Efforts underway to recruit new members, especially youth, through outreach to relevant organizations.

Homeless Children's Network: Pending engagement; highlighted for innovative youth programs.

Westside Crisis: Site visit done; awaiting presentation for potential recognition.
