Public Comments: Amelia, representing Rams, requested that the commissioners conduct site reviews and invite the Dore Urgent Care and Geary Stabilization Unit to make a presentation. Theresa, a new applicant for the commission, introduced herself and expressed their interest in joining the board.

Item 5.0 Discussion

Homeless Children's Network was added to the list for presentations or site visits.

An agreement was reached to Identify two or three additional programs for the 2026 annual report. The Friendship House site visit will be included in the 2025 report.

A suggestion was made for the BHC to schedule a Youth Services Panel presentation for January 2026.

A request was made to have the SF Jail Services schedule a presentation for November 2025.

Follow up with Baker Places Behavioral Health to give an update on their current situation. Suggestions were made to reach out to Homelessness Supportive Housing or the Local

Homeless Coordinating Board to schedule a presentation about supportive housing and behavioral health services in San Francisco.

It was further suggested we find out who to contact in Homelessness Supportive Housing [HSH] for a presentation on how behavioral health funds are utilized.

Site visits to Door Psychiatric Urgent Care and Geary Stabilization Unit were requested for early 2026.

The discussion highlighted the upcoming presentations scheduled for Thursday, November 20, 2025, by Jail Behavioral Health Services, Health Right 360, and Behavioral Health Access Center. Additionally, a presentation from Behavioral Health Transitional Aged Youth Systems of Care took place during the October 2025 BHC meeting. Friendship House presented at the September 2025 BHC meeting.

It was proposed that the BHC should recognize outstanding services provided by San Francisco community agencies, such as Friendship House, Health Right 360's specific program sites, and others. No draft commendations have been submitted to the BHC clerk at this time.
