7. Cristin Kearns, DDS - UCSF School of Dentistry – Sugar Industry Influence on Oral Health [Discussion and Possible Action] 60 minutes

Dr. Kearns shared her research of the Sugar Association and how the government may have exonerated the link between sugar and chronic disease. She authored an article that focused on how the sugar industry influenced the 1<sup>st</sup> FDA government report that exonerated sugar. The article demonstrated how the sugar industry did to successfully influence the FDA report. The Sugar Industry submitted the FDA report to the Public Relations Society Association described the FDA report as “highly supportive.... making it unlikely that sugar will be subject to legislative restriction in the coming years.”

Dr. Kearns studied the history of the work of the Sugar Association. In 1943 the U.S. Dept of Agriculture noted that sugar does not add any nutritional value to the body. The Sugar Association then organized, since the statement would affect sugar sales. Dr. Kearns presented sugar and tobacco parallels: form research organizations, fund research to support industry position, cultivate relationships with policymakers and disseminate interest group data to policymakers. She also shared the history between public health efforts/messaging and the sugar industry as it related to the prevention of dental caries.

There are still interactions and funding relationships with research organizations and sugar and sugar beverage companies. Dental research organizations take funds from major sugar and sugary beverages companies and is not looked at critically as it should be.

Dr. Kearns aims to unravel the story behind the reports and would like to begin focusing on actual evidence as reports are continuously recycled. Health professionals have also been targeted and have been going on behind the scenes.

Saeeda noted how the economic system continues to be oppressive to Black and Brown people. It is very much the dollar over public health.

Veronica - the issue of colonization of how sugar impacted the entire slave trade in the US and its impact today to communities.

Irene - issue with sugar is centuries old, driven by capitalism and tactics has changed but the results are the same.

### Public Comment:

May Bosco – ADA take on sugary beverages, outside of CA what other states would be the same level of what you were doing? Xylitol – in a lot of products, is that part of the sugar industry or different groups? Dr. Kearns responds state dental associations and CA is alone on promoting soda tax connected to tooth decay. In the US, behind in what the barriers are for taking on sugar policy.

Katie Ettman, SPUR – provides preemption timeline, legislature enacted law that prevents cities from new sugary drink taxes until 2031. Charter cities could not be held to penalty provision. Happy to chat with others if interested.

Marcos Cruz, Mission Oral Health Task Force – thanks to Dr. Kearns and can bring back information to community, useful to use as part of oral health campaign, or materials.
