Individual commissioners were assigned to draft brief description of educational topics to cover in 2026 meetings: Al implications on elections (LiVolsi), outreach to other elections commission re: professional development best practices (McNeil), language access (Wong), Open-Source voting (Parker), qualitative election issues and barriers for voters (Bers). Also to consider: community engagement and outreach so the public knows these learning opportunities are available.

Other potential goals to be discussed in future meetings.

Public comment:

- Tom Slackman expressed interest in open Commission seats to be filled with more
 political diversity, appointing a non-Democract. He also shared concerns related to
 non-American ballot counters, incorrect country abbreviations in birth code tables,
 and voter roll clean-up.
- George from the Election Integrity group expressed support for public involvement and education ideas, and suggested a "election expo" for candidates and ballot issues.
