6. Governmental Reports

Agency	Discussion
SFPD Report: Nicole Jones, Commander of Traffic Division and MTA liaison	 Recently debuted a new traffic enforcement plan. We worked hard to get a plan this year. Data driven enforcement to prevent serious and fatal crashes. Have a lot of quantitative data with MTA. We want to hear the qualitative data from groups like this. Perception of safety is huge, and we want to increase and measure our enforcement. Questions?

- D9 question: why has SFPD ignored our invitation to join until now. We even had our Supervisors reach out, and first time I have seen police attend in the 1.5 years I've been on the list. What has changed to make this a new priority? We are happy to have you, and we think it's very important to have some enforcement element to support MTA's infrastructure work. Also, what is your plan for traffic rules in bicycle infrastructure to avoid profiling?
 - New policy effective soon, focusing on reducing profiling.
 We are required by the state to record stops by perceived demographics.
 - We want to be a part of the meetings going forward. We want to work together with the BAC
- Number one focus is speed. Speed is the number one factor for the difference bw life and death.
- D7 question: please help keep scooters off of sidewalks, they go very fast with pedestrians. Esp if cars are taking a right turn, and the scooters are going fast through an intersection, the car or cyclist doesn't know to look for a scooter approaching fast off the sidewalk.
 - We are focusing on data driven factors of safety to enforce, and, sadly, this is not one of them.
- D3: Polk is my main thoroughfare for riding in the city. It's mostly blocked and puts me directly in the line of cars who may be driving unsafely.
 - We can communicate this and pay attention to Polk.

 - Jon Spangler:
 - Right now we have 24 traffic enforcement officers. Overall we are down 500 officers, so until we get more officers, our division is impacted. We are recruiting!
 - Luke Bornheimer: traffic citations are down 97% since 2013 & funding is up.

 - We are ramping up our mountain bike unit!

SF Dept of Public Celebrated BTWD with our director and rode Market to SVN. Works: Clinton Supervisor Peskin was there. Otwell Hairball is going to be cleaned tomorrow per our bicycle street sweeper dispatcher Bay to Breakers clean up 13th street safety improvement plan from Isis to Valencia start date on Jan 2025. Challenges: Mechanical sweepers are not the most reliable machines. • When they go to procure them, they try to get the cheapest • Hairball: agreement for caltrans has to do with the STREET and not the bike lane. Will get more details on that, and that is helpful for me to know re why it is so challenging. • D9: I'm disappointed that Bay to Breakers was the reason that the fell bike lane was cleaned. I hope that everyday reasons will be enough reasons to get the bike lane cleared. BART Bicycle BBATF will have an update on the RSR Bridge Multi-use Path at our June 3 meeting (via ZOOM only).
