**Chief's Report**

- **Weekly crime trends**
- **Major/Significant Incidents**

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 19 percent; homicide down 33 percent; rape down 20 percent; robbery down 24 percent; assault down 14 percent; human trafficking up 100 percent. Property Crimes down 26 percent; burglary down 26 percent; motor vehicle theft down 44 percent; arson down 18 percent; larceny theft down 21 percent. Gun violence is down 28% compared to 2024; One non-fatal shooting incident this week; total 67 fire-arm related

incidents resulting in 81 victims YTD. One homicide for the week; there is a total of 16 homicides YTD with 13 resulting from a firearm; 153% overall clearance.

**Updates:** Homicide reward legislation- looking at a possible department notice for directive to move forward with legislation. Civil immigration enforcement- department notice posted, policy in line with other policies. Crime Alert System, Deputy Chief Lew to have conversation with DEM. Recruitment and staffing – complex question that requires a presentation, looking into presentation by Deputy Chief Jones and Captain Frost. Clearance rates year to date updates.

**Significant Incident:** Officer involved shooting in the Bayview, involved Ingleside Office, 9/4 Northbound US 101 at Cesar Chavez off ramp, details to be provided at the Town Hall meeting on 9/12. One homicide, no arrests. One shooting resulted in injuries to one victim, Golden Gate and Leavenworth, Tenderloin, 9/3 19:42, reports of multiple shots fired, victim located and transported in serious condition, suspect approached victim argument ensued, suspect shot at victim, victim returned fire, suspect discarded firearm, video footage reviewed by RTIC resulted in retrieval of firearm, suspect still outstanding. Two shooting incidents occurred Tuesday. Shooting 400 block of Ellis Street, Starlight Market, Tenderloin, 9/9 17:08, victim and suspect in verbal argument, victim shoved suspect, suspect produced firearm and shot victim one time, suspect fled, victim transported, no arrests. Shooting in Bayview, 9/9 17:48, multiple victims, physical altercation occurred at an illicit cannabis operation, during altercation multiple shots fired, injuring 6 individuals, one treated outside of San Francisco, self-transported, ongoing investigation. Traffic collision, 9/4 17:17 at Laguna Honda, Park District. Traffic Collision, LRV v Pedestrian, 9/7 16:30, Tenderloin, Larch St, pedestrian became wedged between train and elevated platform causing serious injuries. Police recruit passing involving medical emergency, multiple investigations ongoing.

**Significant arrest:** 9/9 shots fired at SFGH 18:38 while on scene at hospital officers and investigators heard several shots from the 23rd street side of hospital, Sergeant responding stopped a driver, no injuries, recovered a firearm and Sergeant made an arrest who is believed to be shooter at hospital. Possession of loaded firearm, large capacity magazine, serial number removed, Mission District, arrest on 9/1 22:26, 24<sup>th</sup> and Mission. Arrest - possession of firearm by prohibited person resisting arrest, Tenderloin, 9/5 16:23, Holiday Plaza. Burglary Hot Prowl unlawful entry stolen vehicle arrest made in Park district, 9/5 03:06, 1600 block of Tate, assigned to Burglary, arrest made. Arrests following investigation of multiple illegal gambling operations, multiple units assigned, executed search warrants at businesses at multiple locations, arrests made, multiple charges. 9/3 09:20 suspects arrested involved in robberies in the Northern District. 9/3 09:15 robbery with force, Hayes and Divisadero, Northern, victim exited Muni when subject approached her from behind, grabbed a gold necklace from her neck, tried to grab purse but unsuccessful, suspect fled into waiting vehicle, RTIC able to identify suspect's license plate, vehicle located on I80East, RTIC coordinated with CHP helicopter, felony stop initiated, all three suspects inside arrested. Arrest – robbery with force in Mission, 9/6 23:43, 2000 block of Market, assigned to robbery detail. Sixty arrests made in a DMACC fugitive recovery enforcement operation, 9/3.

Chief of Staff, Sharon Woo, on behalf of Executive Director Henderson, reported the following: In the year 2025: 650 cases opened; 652 closed; 86 pending; 26 cases sustained; 10 cases past 270-day; 8 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting DPA Report)**: 18. Central, 3. Southern, 3. Bayview, 1. Mission, 1. Northern, 0. Park, 1. Richmond, 1. Ingleside, 1. Taraval, 3. Tenderloin, 1. Airport, 2. Not Applicable, 0. Out of Jurisdiction, 0. Pending, 1 Allegation Summary: Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-42%. Unwarranted Action-The officer issued a citation without cause-8%. Neglect of Duty-The officer failed to properly investigate-8%. Neglect of Duty-The officer failed to activate BWC-8%. Misconduct-The officer used unnecessary or excessive force-8%.

**Outstanding Issues:** DPA Digital Accessibility and Inclusion Standard (DAIS) Project, New Compliance Requirement: A new federal rule mandates that all state and local government entities serving populations of 50,000 or more must comply with the Web Content Accessibility Guidelines (WCAG) 2.1, Level AA, by April 24, 2026, Accessibility Standards: These guidelines ensure that digital content is: Perceivable – Information must be presented in ways users can perceive (e.g., text alternatives for non-text content), Operable – Interfaces must be navigable via keyboard and accessible to all users, Understandable – Content must be readable and predictable, Robust – Content must be compatible with current and future assistive technologies. Officer Involved Shooting, o Incident Overview: On September 4, 2025, an officer-involved shooting occurred on U.S. Highway 101 at the Cesar Chavez Street/Potrero Avenue exit. o DPA Response: The Department of Police Accountability (DPA) responded to the scene within one hour of being notified and promptly initiated an administrative investigation. o SFPD Coordination: The San Francisco Police Department (SFPD) provided timely notification and granted DPA full access to the scene.

**Outreach:** DPA continues to make its services and resources more accessible: In collaboration with SF Digital Services, DPA is reviewing and updating over 500 files and webpages on its website to ensure full compliance with these standards
