Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on the police building ties and working closely with members of the communities.

- <u>Homeless Outreach and Outreach to Drug Users</u>: Southern Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- <u>Foot Patrols</u>: Southern Station has beat officers assigned to the Mission Street corridor from 4th St to 9th St and on 6th St between Mission St and Howard St.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Southern Station sends out newsletter updates to residents in the district that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the district station.
- <u>Twitter:</u> Southern Station's Twitter sends out the updates on upcoming community events, notable arrests and crime alerts.



Crime Definition

- **Robbery** Robbery is the taking of property from another by using force or by using fear.
- **Assault** An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.
- **Battery (Misdemeanor battery)** is any willful and unlawful touching of another. **(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.
- <u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.
- **Aggravated Assault** Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.
- **Burglary** The intent upon entry into a property to commit grand theft, petty theft, or any felony.
- **Grand Theft** Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.
- Petty Theft Theft where the value of the property taken is less than \$950.

Customized Child Safety Presentations



Safety tips





Walking

- Walk with purpose
- Keep your purse or bag close to your body
- · Hide valuables
- Always stay aware of your surroundings
- Take care using cell phones in public, they are commonly targeted by thieves



Parking

- Don't leave packages or bags visible in a parked car
- Put packages in the trunk before you arrive at your destination
- Check signage to make sure your car is parked legally
- · Avoid large bushes and dense shrubbery



Social Media

- · Limit location sharing
- · Tighten privacy settings
- · Be cautious of "friending" strangers
- Don't share details like address, vacation dates, DOB with people you just met
- What goes online will stay online, so be cautious what you share



Taxi and Ridesharing

- Confirm "San Francisco Taxicab" seal
- Check for taxi medallion on the dashboard, note ID number
- Confirm driver identity
- · Choose the back seat
- Cash is never required in a rideshare
- Report incidents to SFPD
- Taxi complaints: call 311



Public Transportation

- Plan your route ahead of time using www.511.org or www.sfmta.org
- Find arrival times using Nextbus.com
- Have money or Clipper card ready
- Stay awake and alert
- · Hold bags in your lap or under your arm
- Thieves may "snatch and grab" by a door when you approach a stop
- Report any incidents to the driver
- After 6:30 pm, Muni bus drivers can make "safe in between stops"—ask your driver

Safety tips

STORM SAFETY TIPS



Take steps to be prepared for storms and stay safe.

Never touch downed wires.

Assume any downed power line is energized and extremely dangerous.

Call 911 and PG&E at 1-800-743-5002.



Charge cell phones and laptops.

Prepare for power outages by charging cell phones and laptops. Have a backup power supply.



Secure your outdoor furniture.

Secure items that can be blown by high winds and damage overhead power lines and property.

Have fresh drinking water and ice.

Freeze containers filled with water and place in your refrigerator during an outage to prevent foods from spoiling.



Use generators safely.

Standby electric generators should be properly installed by a licensed electrician and placed in a well-ventilated area.

Use flashlights, not candles.

During a power outage, use battery-operated flashlights, not candles, due to risk of fire.

DRIVING YOU GO


Check road conditions.

Call 511 or visit your state's DOT webpage to check on road conditions. Choose a different route or adjust your travel plans if road conditions are poor.

Stock your vehicle with a mobile phone. charger, batteries, blankets, flashlight, first-aid kit, high-calorie, non-perishable food, candle to melt snow for drinking water, sack of sand or cat litter for traction, shovel, scraper, and battery booster cables.

Get the weather forecast.

Change your travel plans if hazardous weather is expected.




Check your battery, wipers, coolant,

and other systems affected by cold

temperature. Make sure your tires

have good tread. Clear snow, ice or dirt

from your windows, lights and camera.





With the Covid-19 restrictions lifting in phases and many of us are starting to venture out again, here are some Package Theft Prevention Guide from SFSafe to help prevent your packages from being stolen.



PACKAGE THEFT PREVENTION GUIDE

WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

🗀 USE SPECIAL SERVICES

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.

CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.





PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.





ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



HAVE A QUALITY, FUNCTIONING GARAGE

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.




INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.



ANATOMY OF A SAFE GARAGE



Your home is only as safe as its weakest entry point.

Your garage is an important part of your home and securing your garage is one of the most essential steps to securing your entire home. It is always recommended to regularly check and update your home's security system and safety measures.

PREVENT THEFT FROM YOUR VEHICLE

Remember when parking your vehicle to ensure it is properly secured before walking away. Be sure that your windows are up, and your doors are locked. Thieves often check door handles to see if a car is unlocked. Remove all valuables from the inside of your car and take them with you. PARK SMART! Flyers available in English -Chinese - Spanish



Safe Habits to Adopt:



Turn off the ignition
Never leave your car running unattended



Keep your vehicle & tires in good condition to prevent breakdowns—stranding you in a dark or unfamiliar place



Lock your doors when you get in your car



See something, say something
If you see a motorist in distress, call 9-1-1
versus stopping to help



Clear your trunk and take your valuables with you every time you leave your car



If you are being followed, drive to the nearest police or fire station a populated area is a good default





In an effort to improve vehicular and pedestrian safety Citywide, <u>TransBASEsf.org</u> has identified dangerous intersections in the Southern District. We have implemented the "**Focus on the Five**" traffic safety initiative. Southern Station Officers will be engaging in increased traffic enforcement at these intersections and other locations in the district. Refer to the <u>TransBASEsf.org</u> for more detailed information.

Focus on the Five Dangerous Intersections

- Mission St @ 8th St
- 5th St @ Bryant St
- Howard St @ 6th St.
- 6th St @ Harrison
- 10th St @ Mission St

22450(a) CVC: The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection

21453 (a) CVC: A driver facing a steady circular red signal alone shall stop at a marked limit line, but if none, before entering the crosswalk on the near side of the intersection, and shall remain stopped until an indication to proceed is shown.

22350 CVC: No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

21950(a) CVC: The driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

22107 CVC: No person shall turn a vehicle from a direct course or move right or left upon a roadway until such movement can be made with reasonable safety and then only after the giving of an



SHARING THE ROAD WITH CYCLISTS

When it comes to safely sharing the road with cyclists it's paramount for drivers to learn how to coexist.

Share the Road

When out and about, drivers need to be evermindful of sharing the road with cyclists.

Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

Stay Off the Horn

Sudden hoking might startle a cyclist and can cause them to swerve into traffic or off the road.

Mind Your Blind Spots

Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.





San Francisco Police Arrest Armed Robbery Crew

On Monday, March 28, 2022, at approximately 3:10 p.m., SFPD officers from Bayview Police Station responded to the 1000 Block of Mississippi Street regarding an attempted carjacking. Upon arrival, officers met with the 37-year-old Asian male victim who told them that four black males approached him as he was sitting in his vehicle. One of the males ordered the victim to get out of his vehicle but the victim refused. Another male then pointed a firearm at the victim and again ordered the victim to get out of his vehicle. Fearing for his life, the victim exited his vehicle and ran away from the suspects. The suspects were unable to take the victim's vehicle as the victim still had his car keys with him when he ran off. Officers canvassed the area for witnesses and evidence. No injuries were reported.

Approximately one hour later at 4:08 p.m., SFPD officers from Park Police Station responded to the 100 Block of Galewood Circle regarding a carjacking. Upon arrival, officers met with the 76-year-old Asian male victim. The victim stated that he was cleaning his vehicle inside his open garage when four black males entered and demanded his car keys. One of the suspects then dragged the victim out of the garage, pushed him to the ground and proceeded to assault him. While on the ground, the suspects went through the victim's pockets and took his car keys. The suspects then got in the victim's BMW and drove off. The victim suffered non-life-threatening injuries and was treated at the scene.

Approximately fifteen minutes later, while officers were still conducting their investigation on Galewood Circle, dispatch began receiving phone calls regarding a BMW driving recklessly on Interstate 80 towards the Bay Bridge. Dispatch broadcast this information over SFPD radios. Officers from Tenderloin Station located the vehicle traveling westbound on Interstate 80. The BMW that was driving recklessly matched the description of the victim vehicle from the carjacking on Galewood Circle. Officers attempted to conduct a traffic stop on the BMW, however the vehicle immediately fled at a high rate of speed. Officers initiated a vehicle pursuit across the Bay Bridge towards Treasure Island. The suspects exited onto Treasure Island and were involved in a traffic collision. After a brief foot pursuit, two suspects were taken into custody.

The suspects were identified as a 14-year-old male juvenile and 16-year-old male juvenile both of Oakland. During the investigation of the collision, officers located a semi-automatic handgun that was determined to have been discarded by one of the suspects during the foot pursuit.

Officers developed probable cause to arrest the two juveniles for the below listed charges.

The 14-year-old juvenile was be booked at Juvenile Justice Center for Assault with a Deadly Weapon (245(a)(1) PC), Elder Abuse (368(b)(1) PC), Burglary (459 PC), Carjacking (215(a) PC), Attempted Carjacking (664/215(a) PC), Attempted Robbery (664/211 PC), Felony Hit and Run (20001(a) CVC), Felony Evasion (2800.1(a) CVC), Kidnapping (207 PC), Conspiracy (182(a)(1) PC), Possession of Stolen Vehicle (10851(a) CVC), Carrying a Firearm in a Public Place while masked (25300(a) PC), Carrying a Loaded Firearm with the Intent to Commit a Felony (25800(a) PC), and Resisting Arrest (148(a)(1) PC).

The 16-year-old male juvenile was booked at Juvenile Justice Center for Assault with a Deadly Weapon (245(a)(1) PC), Elder Abuse (368(b)(1) PC), Burglary (459 PC), Carjacking (215(a) PC), Attempted Carjacking (664/215(a) PC), Attempted Robbery (664/211 PC), Felony Hit and Run (20001(a) CVC), Felony Evasion (2800.1(a) CVC), Kidnapping (207 PC), Conspiracy (182(a)(1) PC), Possession of Stolen Vehicle (10851(a) CVC), and Resisting Arrest (148(a)(1) PC).

About the San Francisco Police Department:

The San Francisco Police Department stands for safety with respect for all. Hailed by the New York Times as a major city department "where police reform has worked," SFPD continues to break ground with its voluntary Collaborative Reform Initiative and its work on Mayor London Breed's ambitious Roadmap for Police Reforms. Since 2018, the department has worked in partnership with the California Department of Justice to implement 272 recommendations that aspire to make SFPD a national model of 21st Century policing. Summaries of Supreme Courts Case Laws

(Released Every 3 Months-First Week January, April, July, October)

Kansas v. Glover (2020) 140 S.Ct. 1183.

A Kansas deputy sheriff ran a license plate check on a truck and discovered that the registered owner had a revoked driver's license. The deputy assumed the registered owner was driving the vehicle and pulled it over. The registered owner, Glover, was in fact driving and charged with being a habitual offender. Thereafter, Glover moved to suppress the evidence, claiming that the deputy lacked reasonable suspicion to detain him.

The United States Supreme Court held that, "when the officer lacks information negating an inference that the owner is the driver of the vehicle, the stop is reasonable." The Court noted that the Fourth Amendment permits an officer to detain an individual when that officer has a "particularized and objective basis for suspecting the particular person stopped of criminal activity." Officers must be permitted to make commonsense judgements and inferences regarding human behavior. The Court found that prior to pulling the vehicle over, the deputy observed an individual operating the vehicle, he knew the registered owner had a revoked license, and the model of the vehicle matched what he observed. From these facts the deputy drew the commonsense inference that the driver was the registered owner and the Court found that provided more than reasonable suspicion to initiate the traffic stop.

People v. Henderson (2020) 9 Cal.5th 1013

Henderson was convicted of first degree murder with special circumstances, the personal use of a deadly weapon, and sentenced to death which triggered an automatic appeal to the California Supreme Court. Following his arrest, and during a custodial interrogation, Henderson initially waived his Miranda rights. When asked if he was present at the scene of the crime, Henderson stated, "Uhm, there's some things that I, uhm, want uh ..." He was again asked if he was present and Henderson continued, "[want] uh, want to speak to an attorney first, because I, I take responsibility for me, but there's other people that..."

Under established Miranda law, officers must terminate a custodial interrogation of a suspect when that individual invokes their right to counsel or to be silent. That being said, "various cases have held that a suspect's use of equivocal words or phrases does not constitute a clear request for counsel." A suspect must unambiguously assert his right to counsel or to remain silent. Courts objectively look to whether the suspect expressed their desire for counsel with sufficient clarity "that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Courts have found the following statements to be equivocal and not an invocation: "maybe I should talk to a lawyer;" "[i]f you can bring me a lawyer;" "I think it'd probably be a good idea for me to get an attorney." In this case the court found that by stating, "[I] want to, speak to an attorney first," Henderson did not use equivocal language and the California Supreme Court found this was a violation of the Fifth Amendment.

San Francisco Police Arrest Stunt & Reckless Driving Suspect

On March 17, 2022 at approximately 12:29 a.m., SFPD officers on patrol were in the area of Eddy and Larkin Streets when they observed a white Ford Mustang speeding and then began doing donuts in the intersection. The officers attempted to affect a traffic stop, but the driver failed to yield and fled from the officers at a high rate of speed while running multiple red traffic lights.

The observing officers obtained the Mustang's license plate number and were able to identify the driver. The officers searched for the driver and located him on the unit block of 8th Street. The officers developed probable cause to arrest the driver, Sean Christopher Crozier, 25-year-old male from San Francisco who was booked into San Francisco County Jail for recklessly evading a police officer (2800.2(a) CVC), recklessly driving (23103(a) CVC), exhibition of speed (23109(c) CVC), failure to obey posted sign (22101(d) CVC), red light (21453(a) CVC), failure to obey posted sign (22101(d) CVC), and speeding (22350(a) CVC).

An investigator from the SFPD Stunt Driving Response Unit assisted in the investigation and authored a vehicle seizure order for the Mustang, which was authorized by a judge.

On March 19, 2022, at approximately 4:00 p.m. the Mustang was located in a parking garage located at Market and 8th Streets. Officers seized the vehicle and had it towed to the vehicle impound lot for a mandatory 30-day hold. Pictures of the subject vehicle are included in this release.

While an arrest has been made this remains an open investigation. Anyone with information is asked to call the SFPD Tip line at 415-575-444 or Text a Tip to TIP411 and begin the text message with SFPD. You may remain anonymous.


CPAB- Project Updates

February 2021

Community Police Advisory Board (CPAB) "CPABs" are community-oriented police advisory boards for each police district. Each CPAB, led by the District Captain for that police district, is comprised of approximately 10 to 15 committed volunteer community members and a representative from the Community Engagement Division of the SFPD. District Captains may choose more members if they wish to accomplish specific tasks. Each district's Board members live and/or work in the communities within that district, where a community may be either a neighborhood with specific needs or a specific demographic. Each member thus represents the diversity of their community. In addition to the district CPABs, there will also be a City-wide CPAB Steering Committee facilitated by SF Safety Awareness For Everyone (SAFE). Two representatives from each Community Police Advisory Board shall be selected to participate in this Committee, with the purpose of sharing information across districts.

Captain Falvey held his monthly CPAB meeting on 02/09. Time was spent discussing upcoming community events.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on the police building ties and working closely with members of the communities.

- <u>Homeless Outreach and Outreach to Drug Users</u>: Southern Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- <u>Foot Patrols</u>: Southern Station has beat officers assigned to the Mission Street corridor from 4th St to 9th St and on 6th St between Mission St and Howard St.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Southern Station sends out newsletter updates to residents in the district that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the district station.
- <u>Twitter:</u> Southern Station's Twitter sends out the updates on upcoming community events, notable arrests and crime alerts.



Crime Definition


- **Robbery** Robbery is the taking of property from another by using force or by using fear.
- **Assault** An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.
- **Battery (Misdemeanor battery)** is any willful and unlawful touching of another. **(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.
- <u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.
- **Aggravated Assault** Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.
- **Burglary** The intent upon entry into a property to commit grand theft, petty theft, or any felony.
- **Grand Theft** Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.
- Petty Theft Theft where the value of the property taken is less than \$950.



PACKAGE THEFT PREVENTION GUIDE

WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

🗀 USE SPECIAL SERVICES

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.

CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.





PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.





ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



HAVE A QUALITY, FUNCTIONING GARAGE

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.




INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.



ANATOMY OF A SAFE GARAGE



Your home is only as safe as its weakest entry point.

Your garage is an important part of your home and securing your garage is one of the most essential steps to securing your entire home. It is always recommended to regularly check and update your home's security system and safety measures.

PREVENT THEFT FROM YOUR VEHICLE

Remember when parking your vehicle to ensure it is properly secured before walking away. Be sure that your windows are up, and your doors are locked. Thieves often check door handles to see if a car is unlocked. Remove all valuables from the inside of your car and take them with you. PARK SMART! Flyers available in English -Chinese - Spanish

22450(a) CVC: The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection

21453 (a) CVC: A driver facing a steady circular red signal alone shall stop at a marked limit line, but if none, before entering the crosswalk on the near side of the intersection, and shall remain stopped until an indication to proceed is shown.

22350 CVC: No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

21950(a) CVC: The driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

22107 CVC: No person shall turn a vehicle from a direct course or move right or left upon a roadway until such movement can be made with reasonable safety and then only after the giving of an



SHARING THE ROAD WITH CYCLISTS

When it comes to safely sharing the road with cyclists it's paramount for drivers to learn how to coexist.

Share the Road

When out and about, drivers need to be evermindful of sharing the road with cyclists.

Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

Stay Off the Horn

Sudden hoking might startle a cyclist and can cause them to swerve into traffic or off the road.

Mind Your Blind Spots

Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.










Crime Data Map (Week)


Comparisons of Bi-Annual Crime Maps

Summaries of Supreme Courts Case Laws

(Released Every 3 Months-First Week January, April, July, October)

Kansas v. Glover (2020) 140 S.Ct. 1183.

A Kansas deputy sheriff ran a license plate check on a truck and discovered that the registered owner had a revoked driver's license. The deputy assumed the registered owner was driving the vehicle and pulled it over. The registered owner, Glover, was in fact driving and charged with being a habitual offender. Thereafter, Glover moved to suppress the evidence, claiming that the deputy lacked reasonable suspicion to detain him.

The United States Supreme Court held that, "when the officer lacks information negating an inference that the owner is the driver of the vehicle, the stop is reasonable." The Court noted that the Fourth Amendment permits an officer to detain an individual when that officer has a "particularized and objective basis for suspecting the particular person stopped of criminal activity." Officers must be permitted to make commonsense judgements and inferences regarding human behavior. The Court found that prior to pulling the vehicle over, the deputy observed an individual operating the vehicle, he knew the registered owner had a revoked license, and the model of the vehicle matched what he observed. From these facts the deputy drew the commonsense inference that the driver was the registered owner and the Court found that provided more than reasonable suspicion to initiate the traffic stop.

People v. Henderson (2020) 9 Cal.5th 1013

Henderson was convicted of first degree murder with special circumstances, the personal use of a deadly weapon, and sentenced to death which triggered an automatic appeal to the California Supreme Court. Following his arrest, and during a custodial interrogation, Henderson initially waived his Miranda rights. When asked if he was present at the scene of the crime, Henderson stated, "Uhm, there's some things that I, uhm, want uh ..." He was again asked if he was present and Henderson continued, "[want] uh, want to speak to an attorney first, because I, I take responsibility for me, but there's other people that..."

Under established Miranda law, officers must terminate a custodial interrogation of a suspect when that individual invokes their right to counsel or to be silent. That being said, "various cases have held that a suspect's use of equivocal words or phrases does not constitute a clear request for counsel." A suspect must unambiguously assert his right to counsel or to remain silent. Courts objectively look to whether the suspect expressed their desire for counsel with sufficient clarity "that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Courts have found the following statements to be equivocal and not an invocation: "maybe I should talk to a lawyer;" "[i]f you can bring me a lawyer;" "I think it'd probably be a good idea for me to get an attorney." In this case the court found that by stating, "[I] want to, speak to an attorney first," Henderson did not use equivocal language and the California Supreme Court found this was a violation of the Fifth Amendment.

San Francisco Police Investigates Ingleside District Homicide

On Sunday, April 3, 2022 at approximately 4:39 p.m. police officers from Ingleside Station responded to a playground located on the 600 block of Brunswick Ave. regarding a shooting. Officers arrived on scene and located four adult male victims with gunshot wounds. Officers rendered aid and summoned medics to the scene who transported the victims to the hospital. Two victims suffered life threatening injuries and two victims suffered non-life-threatening injuries. Despite the lifesaving efforts of the emergency responders and the medical staff the two victims with the life-threatening injuries succumbed to their wounds and were pronounced deceased in the hospital.


CPAB- Project Updates

In addition to the district CPABs, there will also be a City-wide CPAB Steering Committee facilitated by SF Safety Awareness For Everyone (SAFE). Two representatives from each Community Police Advisory Board shall be selected to participate in this Committee, with the purpose of sharing information across districts.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on the police building ties and working closely with members of the communities.

- <u>Homeless Outreach and Outreach to Drug Users</u>: Southern Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- <u>Foot Patrols</u>: Southern Station has beat officers assigned to the Mission Street corridor from 4th St to 9th St and on 6th St between Mission St and Howard St.
- <u>Monthly Police Community Relations Meetings</u>: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Southern Station sends out newsletter updates to residents in the district that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the district station.
- <u>Twitter:</u> Southern Station's Twitter sends out the updates on upcoming community events, notable arrests and crime alerts.



Crime Definition

- **Robbery** Robbery is the taking of property from another by using force or by using fear.
- **Assault** An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.
- **Battery (Misdemeanor battery)** is any willful and unlawful touching of another. **(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.
- <u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.
- **Aggravated Assault** Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.
- **Burglary** The intent upon entry into a property to commit grand theft, petty theft, or any felony.
- **Grand Theft** Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.
- **Petty Theft** Theft where the value of the property taken is less than \$950.



With the Covid-19 restrictions lifting in phases and many of us are starting to venture out again, here are some Package Theft Prevention Guide from SFSafe to help prevent your packages from being stolen.



PACKAGE THEFT PREVENTION GUIDE

WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

🗀 USE SPECIAL SERVICES

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.

CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.



Addressing Crime / Safety tips



PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.





ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



HAVE A QUALITY, FUNCTIONING GARAGE

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.




INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

Your home is only as safe as its weakest entry point.

Your garage is an important part of your home and securing your garage is one of the most essential steps to securing your entire home. It is always recommended to regularly check and update your home's security system and safety measures.

Addressing Crime / Safety Tips

PREVENT THEFT FROM YOUR VEHICLE

Remember when parking your vehicle to ensure it is properly secured before walking away. Be sure that your windows are up, and your doors are locked. Thieves often check door handles to see if a car is unlocked. Remove all valuables from the inside of your car and take them with you. PARK SMART! Flyers available in English -Chinese - Spanish



Safe Habits to Adopt:



Turn off the ignition Never leave your car running unattended



Keep your vehicle & tires in good condition to prevent breakdowns—stranding you in a dark or unfamiliar place



Lock your doors when you get in your car



See something, say something If you see a motorist in distress, call 9-1-1 versus stopping to help



Clear your trunk and take your valuables with you every time you leave your car



If you are being followed, drive to the nearest police or fire station a populated area is a good default

In an effort to improve vehicular and pedestrian safety Citywide, <u>TransBASEsf.org</u> has identified dangerous intersections in the Southern District. We have implemented the "**Focus on the Five**" traffic safety initiative. Southern Station Officers will be engaging in increased traffic enforcement at these intersections and other locations in the district. Refer to the <u>TransBASEsf.org</u> for more detailed information.

Focus on the Five Dangerous Intersections

- Mission St @ 8th St
- 5th St @ Bryant St
- Howard St @ 6th St.
- 6th St @ Harrison
- 10th St @ Mission St

22450(a) CVC: The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection

21453 (a) CVC: A driver facing a steady circular red signal alone shall stop at a marked limit line, but if none, before entering the crosswalk on the near side of the intersection, and shall remain stopped until an indication to proceed is shown.

22350 CVC: No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

21950(a) CVC: The driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

22107 CVC: No person shall turn a vehicle from a direct course or move right or left upon a roadway until such movement can be made with reasonable safety and then only after the giving of an

Addressing Crime / Safety Tips



SHARING THE ROAD WITH CYCLISTS

When it comes to safely sharing the road with cyclists it's paramount for drivers to learn how to coexist.

Share the Road

When out and about, drivers need to be evermindful of sharing the road with cyclists.

Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

Stay Off the Horn

Sudden hoking might startle a cyclist and can cause them to swerve into traffic or off the road.

Mind Your Blind Spots

Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.





Summaries of Supreme Courts Case Laws

(Released Every 3 Months-First Week January, April, July, October)

Kansas v. Glover (2020) 140 S.Ct. 1183.

A Kansas deputy sheriff ran a license plate check on a truck and discovered that the registered owner had a revoked driver's license. The deputy assumed the registered owner was driving the vehicle and pulled it over. The registered owner, Glover, was in fact driving and charged with being a habitual offender. Thereafter, Glover moved to suppress the evidence, claiming that the deputy lacked reasonable suspicion to detain him.

The United States Supreme Court held that, "when the officer lacks information negating an inference that the owner is the driver of the vehicle, the stop is reasonable." The Court noted that the Fourth Amendment permits an officer to detain an individual when that officer has a "particularized and objective basis for suspecting the particular person stopped of criminal activity." Officers must be permitted to make commonsense judgements and inferences regarding human behavior. The Court found that prior to pulling the vehicle over, the deputy observed an individual operating the vehicle, he knew the registered owner had a revoked license, and the model of the vehicle matched what he observed. From these facts the deputy drew the commonsense inference that the driver was the registered owner and the Court found that provided more than reasonable suspicion to initiate the traffic stop.

People v. Henderson (2020) 9 Cal.5th 1013

Henderson was convicted of first degree murder with special circumstances, the personal use of a deadly weapon, and sentenced to death which triggered an automatic appeal to the California Supreme Court. Following his arrest, and during a custodial interrogation, Henderson initially waived his Miranda rights. When asked if he was present at the scene of the crime, Henderson stated, "Uhm, there's some things that I, uhm, want uh ..." He was again asked if he was present and Henderson continued, "[want] uh, want to speak to an attorney first, because I, I take responsibility for me, but there's other people that..."

Under established Miranda law, officers must terminate a custodial interrogation of a suspect when that individual invokes their right to counsel or to be silent. That being said, "various cases have held that a suspect's use of equivocal words or phrases does not constitute a clear request for counsel." A suspect must unambiguously assert his right to counsel or to remain silent. Courts objectively look to whether the suspect expressed their desire for counsel with sufficient clarity "that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Courts have found the following statements to be equivocal and not an invocation: "maybe I should talk to a lawyer;" "[i]f you can bring me a lawyer;" "I think it'd probably be a good idea for me to get an attorney." In this case the court found that by stating, "[I] want to, speak to an attorney first," Henderson did not use equivocal language and the California Supreme Court found this was a violation of the Fifth Amendment.

San Francisco Police Investigates Ingleside District Homicide

On Sunday, April 3, 2022 at approximately 4:39 p.m. police officers from Ingleside Station responded to a playground located on the 600 block of Brunswick Ave. regarding a shooting. Officers arrived on scene and located four adult male victims with gunshot wounds. Officers rendered aid and summoned medics to the scene who transported the victims to the hospital. Two victims suffered life threatening injuries and two victims suffered non-life-threatening injuries. Despite the lifesaving efforts of the emergency responders and the medical staff the two victims with the life-threatening injuries succumbed to their wounds and were pronounced deceased in the hospital.

This investigation is being led by the SFPD Homicide Detail.

San Francisco Police Investigates Bayview District Homicide

On Friday April 1, 2022, at approximately 1:21 p.m., San Francisco Police officers from Bayview Police Station responded to the area of 3rd Street and Palou Avenue for a report of a shooting. Officers arrived on scene and located a 21-year-old male victim suffering from apparent gunshot wounds. Officers rendered aid and summoned medics to the scene. The victim was transported to a local hospital with life-threatening injuries. Despite life-saving efforts the victim succumbed to his injuries and was declared deceased at the hospital. A second victim, a 29-year-old male, was treated at a local hospital for non-life-threatening injuries.

This investigation is being led by the SFPD Homicide Detail.


CPAB- Project Updates

February 2021

Community Police Advisory Board (CPAB) "CPABs" are community-oriented police advisory boards for each police district. Each CPAB, led by the District Captain for that police district, is comprised of approximately 10 to 15 committed volunteer community members and a representative from the Community Engagement Division of the SFPD. District Captains may choose more members if they wish to accomplish specific tasks. Each district's Board members live and/or work in the communities within that district, where a community may be either a neighborhood with specific needs or a specific demographic. Each member thus represents the diversity of their community. In addition to the district CPABs, there will also be a City-wide CPAB Steering Committee facilitated by SF Safety Awareness For Everyone (SAFE). Two representatives from each Community Police Advisory Board shall be selected to participate in this Committee, with the purpose of sharing information across districts.

Captain Falvey held his monthly CPAB meeting on 02/09. Time was spent discussing upcoming community events.
