# Recap of discussion from Phase 2 Presentation

- Discussion related to the textures of the two wall treatments
  - Shotcrete for retaining walls 'above' the roadway
  - Smooth concrete texture for retaining walls below the roadway
  - How the different textures will respond to the stain and its application
- Desire by Commissioners for greater clarity surrounding the 'Trowel Markings' and the process to be utilized in adding this level of detail
- Discussion related to 'less subtlety' between the different 'sections' of the retaining walls
- Dialogue pertaining to the on-going maintenance of the aesthetic treatment once construction is complete

# Aesthetic Treatment Approach & Integration

- The design honors the land by depicting a narrative of the landscape
- The design is referenced from the local topography of the Bay's many islands, mountainous structures colored in harmonious regional earth tones and emerge from the sea and separate themselves by water
- As a rhythm of colored rock moves within the work, a moon phase ascends in tandem to show the passage of time implying the endurance, wisdom and majesty of these terrestrial features
