## **Chief's Report**

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 7 percent; homicide up 2 percent; rape up 9 percent; robbery up 5 percent; assault up 10 percent; human trafficking down 52 percent. Property Crimes up 6 percent; burglary down 21 percent; motor vehicle theft up 4 percent; arson down 10 percent; larceny theft up 13 percent. Gun violence is down 1 percent compared to 2021; One shooting incident for the week ending on 11/13/22; total 167 incident resulting in 190 victims YTD. Three homicides for the week ending 11/13/22; there are a total of 48 homicides YTD with 32 resulting from a firearm; 63% overall clearance. Guns seized 961; ghost guns seized 163 YTD.

Significant Incident: Three homicides: First - 3<sup>rd</sup> and LaSalle in Bayview, attempted robbery of resident, overnight guest gave suspects access to complex, entered complex, one of four suspects was shot and succumbed to injuries, shooter taken into custody, robbery gone bad, investigation ongoing. Second- 100 block of Larkin, Tenderloin, victim in front of Library, victim had no pulse, witness came forward advised of incident, victim pronounced at hospital, no arrest has been made, evidence to follow up on. Third- 700 block of Fulton, Northern, Officers responded to a Shotspotter activation, located victim in street with gunshot wounds, Officers rendered aid, victim succumbed to injuries at hospital, video in area captured portion of incident, numerous suspects, several guns involved, no arrest, investigation ongoing. Series of auto burglaries across city on 11/11/22, Officers observed stolen vehicle in area, stopped vehicle, subjects taken into custody, victims identified. Catalytic converter arrest, Northern, suspects caught in act, arrests made, firearm, multiple charges. Auto burglaries, business victim of 8 auto burglaries, one suspect, iphones taken, autonomous vehicles, images of suspect provided, and suspect identified, multiple charges. Robbery at Grocery Outlet 300 block of Bayshore, robbery of alcohol, stabbing victim-also suspect, victim (security guard) confronted suspects, bystanders and witnesses began to assist, suspects fled, stabbing victim/robbery suspect will be arrested once medical condition cleared. Robbery with force, Central, Portsmouth Square, two victims were performing inside the square, suspects began to yell at them, victim began to record suspects, suspect ran towards victim, victim ran away, suspect hit victim on back of head and took cell phone, victim called 911, Officers arrived and were able to arrest suspect.

Significant arrest: None

Strategies: Union Square/Macys Tree lighting/Ice Rink. Officers, Safe shopper, Ambassadors, Tourism has deployed for holiday season.

DPA Attorney/Acting Director Diana Rosenstein on behalf of Executive Director Henderson reported the following: In the year 2022: 601 cases opened; 636 closed; 245 pending; 53 cases sustained; 23 cases past 270-day; 18 cases mediated. Cases received in the past week: 15 new cases; Central (1) Repeatedly requesting a person's skin color. Southern (1) Excessive force during a detention. Bayview (1) Preventing a person from receiving medical treatment. Mission (5) Driving recklessly, entering a hotel room inappropriately, officer loitering, and making inappropriate comments about a person's race. Northern (1) Failing to investigate a vehicle theft. Park (1) Failing to write an incident report. Richmond (1) Failing to investigate. Ingleside (1) Failing to take action regarding a noise complaint. Taraval (2) Detaining a person without cause and making inappropriate comments via phone. Tenderloin (1) Speaking inappropriately and hanging up on a caller.

Audits: sent draft of first Interim Report about misconduct audit for SFPD's review. DPA and Controller's Officer started 24 month follow up on recommendations made in the Use of Force Audit.
