10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled People of the State of California v. City
12 and County of San Francisco, San Mateo Superior Court, Case No. 25-CIV-06376 by the
13 payment of \$69,054.66. The lawsuit involves alleged violations of the California Hazardous
14 Waste Control Law arising from a July 2023 San Francisco Public Utilities Commission truck
15 spill on a San Mateo County highway.

16 Section 2. The above-named action was filed in San Mateo Superior Court on August
17 22, 2025, and the following parties were named in the lawsuit: plaintiff People of the State of
18 California; defendants City and County of San Francisco and San Francisco Public Utilities
19 Commission.

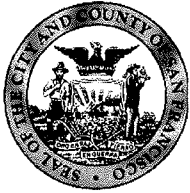
