

1 [Arbor Day - April 24, 2026]

2 **Resolution declaring April 24, 2026, as Arbor Day in the City and County of San**  
3 **Francisco.**

5 WHEREAS, Arbor Day is a nationally recognized observance that promotes the  
6 planting, care, and preservation of trees, fostering environmental stewardship and  
7 strengthening community engagement; and

8 WHEREAS, Arbor Day was first observed in 1872 and has since grown into a global  
9 movement that highlights the importance of trees in building healthier, more resilient  
10 communities; and

11 WHEREAS, Arbor Day serves as a reminder of the long-term investment trees  
12 represent, as those planted today will provide environmental, public health, and community  
13 benefits for generations to come; and

14 WHEREAS, Trees across San Francisco's streets, parks, and public spaces provide  
15 critical benefits including shade, improved air quality, noise reduction, and a sense of calm  
16 and beauty in highly urbanized environments; and

17 WHEREAS, San Francisco is home to some of the most vibrant and densely populated  
18 neighborhoods including South of Market, the Tenderloin, Bayview-Hunters Point, Chinatown,  
19 and others, where access to green space and tree canopy is essential to improving quality of  
20 life; and

21 WHEREAS, Increasing tree canopy in San Francisco is an important step toward  
22 addressing long-standing environmental inequities, particularly in communities that have  
23 historically experienced higher levels of pollution and limited access to green infrastructure;  
24 and

1           WHEREAS, Expanding and maintaining the urban forest in San Francisco plays a vital  
2 role in advancing the City's climate resilience goals by reducing urban heat, sequestering  
3 carbon, and supporting sustainable development in rapidly growing neighborhoods; and

4           WHEREAS, The planting and stewardship of trees in San Francisco is made possible  
5 through the collective efforts of residents, neighborhood groups, community-based  
6 organizations, and City agencies working collaboratively; and

7           WHEREAS, Local initiatives that engage youth, families, and community members in  
8 tree planting and care foster environmental awareness, civic pride, and stronger  
9 neighborhood connections; and

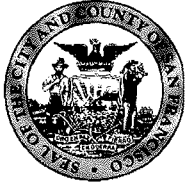
10           WHEREAS, Arbor Day offers a meaningful opportunity for San Franciscans to come  
11 together in neighborhoods across the City to plant trees, care for existing ones, and deepen a  
12 shared sense of stewardship over the City's urban forest; and

13           WHEREAS, Arbor Day also provides an opportunity to uplift these community-led  
14 efforts and reaffirm a commitment to expanding equitable access to trees and green space  
15 across San Francisco; now, therefore, be it

16           RESOLVED, That the Board of Supervisors hereby declares April 24, 2026, as Arbor  
17 Day in the City and County of San Francisco; and, be it

18           FURTHER RESOLVED, That the City and County of San Francisco encourages  
19 residents to celebrate Arbor Day by engaging in tree planting, stewardship, and appreciation  
20 of the City's urban forest; and, be it

21           FURTHER RESOLVED, That the City and County of San Francisco reaffirms its  
22 commitment to expanding and maintaining a healthy, equitable urban forest, with a focus on  
23 dense neighborhoods where an increased tree canopy can have the greatest impact on public  
24 health, climate resilience, and community well-being.
