

1 [Consolidation of Elections Scheduled for June 2, 2026]

3 **Resolution consolidating the following elections, all of which will be held on June 2,**
4 **2026: the State of California’s Direct Primary Election; the City and County of San**
5 **Francisco Municipal Election; the San Francisco Unified School District Board of**
6 **Education Election; and the City and County of San Francisco’s Special Bond Election;**
7 **and providing that the election precincts, voting places, and officers for these elections**
8 **shall be the same as for the Statewide Direct Primary Election.**

10 WHEREAS, The State of California will hold a Statewide Direct Primary Election on
11 June 2, 2026, for the purpose of voting on candidates for federal and state offices; and

12 WHEREAS, The City and County of San Francisco will hold a municipal election on
13 June 2, 2026, for the purpose of voting on proposed local ballot measures to be submitted to
14 the voters; and

15 WHEREAS, The San Francisco Unified School District will hold an election on June 2,
16 2026, for the purpose of voting on candidates for the Board of Education; and

17 WHEREAS, The Board of Supervisors has called a special election to be held in the
18 City and County of San Francisco on June 2, 2026, for the purpose of voting on a proposed
19 general obligation bond measure, and consolidated the special municipal bond measure
20 election with the Statewide Direct Primary Election scheduled for the same date; and

21 WHEREAS, The Board of Supervisors believes that it is in the best interest of the
22 public that these elections be consolidated, as authorized by law; now, therefore, be it

23 RESOLVED, That pursuant to California Elections Code, Section 10400 et seq., the
24 Statewide Direct Primary Election, the City and County of San Francisco Municipal Election,
25 the San Francisco Unified School District Board of Education Election, the City and County of

1 San Francisco's Special Bond Election, on June 2, 2026, shall be and hereby are
2 consolidated; and, be it

3 FURTHER RESOLVED, That the voting precincts, polling places, and officers of the
4 Statewide Direct Primary Election, the City and County of San Francisco Municipal Election,
5 the San Francisco Unified School District Board of Education Election, and the City and
6 County of San Francisco's Special Bond Election, shall, in every case, be the same; that there
7 shall be only one set of election officers in each precinct, to wit, the election officers to be
8 appointed by the Director of Elections for each precinct; that all candidates, ballot measures
9 and bond proposals shall be set forth on the ballots provided for said election; that the
10 elections shall be held in all respects as though there were only one election, and that all
11 returns shall be canvassed by the Director of Elections as provided in the California Elections
12 Code.
