

1 [Contract - St. Vincent de Paul Society of San Francisco - Multi-Service Center South –
2 Emergency Shelter Operations and Supportive Services - Not to Exceed \$35,507,789]

3 **Resolution approving the contract between the St. Vincent de Paul Society of San**
4 **Francisco and the Department of Homelessness and Supportive Housing (“HSH”), for**
5 **emergency shelter operations and support services at Multi-Service Center South, for a**
6 **term of July 1, 2026, through June 30, 2029, for a total amount not to exceed**
7 **\$35,507,789 and authorizing HSH to enter into any amendments or other modifications**
8 **to the contract that do not materially increase the obligations or liabilities, or materially**
9 **decrease the benefits to the City and are necessary or advisable to effectuate the**
10 **purposes of the Agreement.**

12 WHEREAS, The mission of the Department of Homelessness and Supportive Housing
13 (“HSH” or “Department”) is to prevent homelessness when possible and make homelessness
14 rare, brief, and one-time in the City and County of San Francisco (“the City”) through the
15 provision of coordinated, compassionate, and high-quality services; and

16 WHEREAS, The City is committed to expanding and diversifying shelter services for
17 people living unsheltered in our community; and

18 WHEREAS, As of the 2024 Point-in-Time Count, there were approximately 8,323
19 people experiencing homelessness in San Francisco on any given night, 52% of whom were
20 unsheltered; and

21 WHEREAS, St. Vincent de Paul Society of San Francisco (“SVDP”) has extensive
22 experience operating emergency shelter programs; and

23 WHEREAS, SVDP has operated an emergency shelter at Multi-Service Center South
24 (“MSC South”) since 1989; and

1 WHEREAS, HSH awarded the Contract to SVDP through the Department's
2 streamlined contracting authority for homeless services under Administrative Code, Chapter
3 21.B; and

4 WHEREAS, HSH intends to enter into a Contract for a term of July 1, 2026, through
5 June 30, 2029, and a total not to exceed amount of \$35,507,789; and

6 WHEREAS, The Contract is consistent with the Civil Service Commission's approval
7 obtained on March 2, 2026, under Personal Service Contract No. DHRPSC0006053; and

8 WHEREAS, The Contract requires Board of Supervisors approval under Charter,
9 Section 9.118; now, therefore, be it

10 RESOLVED, The proposed Contract contained in File No. 260459, is substantially in
11 final form, with all materials terms and conditions included, and only remains to be executed
12 by the parties upon approval of this Resolution; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors authorizes HSH to make any
14 modifications to the Contract, prior to its final execution by all parties, that HSH determines, in
15 consultation with the City Attorney, are consistent with this Resolution, in the best interest of
16 the City, do not materially increase the obligations or liabilities of the City, are necessary or
17 advisable to effectuate the purposes of the Contract, and are in compliance with all applicable
18 laws, including City's Charter; and, be it

19 FURTHER RESOLVED, That within 30 days of the Contract being fully executed by all
20 parties, HSH shall submit to the Clerk a completely executed copy for inclusion in File
21 No. 260459; this requirement and obligation resides with the Department, and is for purposes
22 of having a complete file only, and in no manner affects the validity of approved Contract.

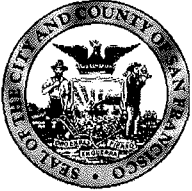
