3 **Resolution commending Planning Commission Vice President Kathrin Moore for her**
4 **outstanding and dedicated service as a Planning Commissioner of the City and County**
5 **of San Francisco.**

7 WHEREAS, Planning Commission Vice President Kathrin Moore, first appointed to the
8 Planning Commission in 2006 by President of the Board of Supervisors Aaron Peskin, has
9 been reappointed four times, in 2010 and 2014 by Board President David Chiu, in 2018 by
10 Board President Malia Cohen, and in 2022 by Board President Shamann Walton, making her
11 one of the longest-serving Planning Commissioner in the last 100 years; and

12 WHEREAS, In her 20 years of service as Planning Commissioner, she has worked
13 under four Mayors, collaborated with four Planning Directors, 45 Supervisors, 24 Planning
14 Commissioners, three Zoning Administrators, two Commission Secretaries; and has been
15 elected to serve as Commission Vice President seven times by unanimous votes of her
16 colleagues, a distinctive mark of her impressive value to the Commission; and

17 WHEREAS, Commissioner Moore's distinguished service to the City and County of
18 San Francisco began in 2001 with her appointment to the Treasure Island Citizens Advisory
19 Board (TI CAB) by Supervisor Mark Leno, where she served until 2015 after the Master Plan
20 for Treasure Island was approved by both the Planning Commission and the Board of
21 Supervisors in 2012; and

22 WHEREAS, Her impact and effectiveness as a community leader 2005 appointment by
23 Mayor Gavin Newsom to the Port of San Francisco Waterfront Design Advisory Committee
24 (WDAC), an appointment that Commissioner Moore still holds today, and her familiarity with
25 the larger issues surrounding the Waterfront Plan have consistently added insight to the

1 robust discussions surrounding the review of many notable projects, including: The James R.
2 Herman Cruise Terminal - 2011; The Exploratorium - 2012; America's Cup - 2012; Brennan
3 Street Pier - 2014; Golden State Warriors Arena - 2014; Crane Cove Park - 2016; Ferry
4 Terminal Expansion Plan - 2016; and the Pier 70 Extension - 2017; and

5 WHEREAS, From 2013 to 2015, she served as ex-officio member on the San
6 Francisco Arts Commission; and

7 WHEREAS, Commissioner Moore has been the informed voice for excellence in urban
8 design and planning and the trusted Commissioner for deeply understanding and representing
9 neighborhood concerns in the resolution of outcomes with other commissioners, her
10 recognition and awards from different neighborhood groups are testimony of the public's
11 appreciation for her commitment to sound planning, the citizens of San Francisco, and its
12 diverse neighborhoods; and her notable achievements in city-wide planning include: The
13 Market Octavia Plan - 2008; Eastern Neighborhood Plan - 2009; Transit Center District Plan -
14 2011; America's Cup 34 - 2012; Golden State Warriors Arena Mission Bay - 2015; Market
15 Street Hub - 2016; Mission 2020 Action Plan - 2017, and San Francisco Housing Element -
16 2023; and

17 WHEREAS, The consistency and knowledge that Commissioner Moore brings to
18 planning and its public process have instilled trust and credibility with residents, neighborhood
19 groups, and decision-makers at City Hall; now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
21 commends Commissioner Kathrin Moore for her outstanding and dedicated service, and
22 wishes her the best on her next adventure.

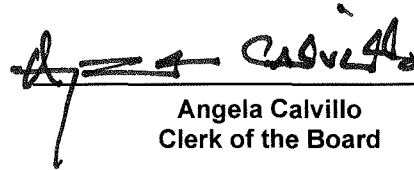

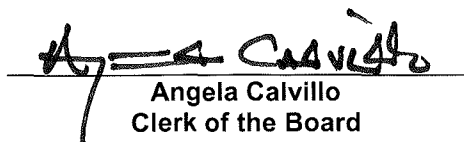
