3 **Resolution authorizing the Office of the District Attorney to accept and expend a gift**
4 **in the amount of \$200,000 from The Chris Larsen Fund facilitated by the Silicon**
5 **Valley Community Foundation through Five Keys to support a women's initiative,**
6 **Project Restore: Women's Housing for victims of crime, geared towards servicing**
7 **families of violent crime for the purpose of public safety prevention efforts.**

9 WHEREAS, The acceptance or expenditure of any gift of cash or goods of a market
10 value greater than \$10,000 shall require approval of the Board of Supervisors, by
11 resolution; and

12 WHEREAS, The Chris Larsen Fund facilitated by the Silicon Valley Community
13 Foundation gifted \$1,000,000 to Five Keys to support services for families of violent crime
14 for the purpose of public safety prevention; and

15 WHEREAS, Five Keys will allocate \$200,000 of the \$1,000,000 to the San Francisco
16 District Attorney's Office; and

17 WHEREAS, The \$200,000 will be used to cover a victim advocate position and
18 program costs for victim needs in support of a women's initiative; and

19 WHEREAS, The gift does not require an Annual Salary Ordinance (ASO)
20 amendment; and

21 WHEREAS, Indirect costs are not included by the Office of the District Attorney to
22 maximize use of funds on direct services; now, therefore, be it

23 **RESOLVED, That the Board of Supervisors hereby approves the acceptance and**
24 **use of the \$200,000 gift from the Chris Larsen Fund facilitated by the Silicon Valley**
25 **Foundation, funded through Five Keys to support the San Francisco District Attorney's**

1 Office women's initiative that will provide services to families of violent crime and promote
2 public safety prevention efforts; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
4 indirect costs in the gift budget; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors extends its gratitude to The
6 Chris Larsen Fund facilitated by the Silicon Valley Community Foundation for the generous
7 gift to the Office of the District Attorney.

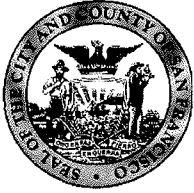
