Off-Site Facilities Update...

- 54 prospective facilities, to date, have been vetted
- Approximately 19 locations, to date, have confirmed availability
- We have sufficient potential facility options for all 11 Districts that can accommodate 100+ people
- Prospective facilities include SFUSD, Rec & Park, Library, SFPD, and community partner sites
- Facility accommodations (PA, WiFi/Ethernet, tables/chairs, custodial services, transit, etc.) and potential costs will be evaluated
- 3-4 weeks advanced reservations
